Unitarian Universalist Church of Berkeley July 2020 Treasurer's Report Larry Nagel, Treasurer August 30, 2020

This is the first report for Fiscal Year 2020-21 and it will appear a little different from previous reports. The Finance team of Tess O'Riva, Diana Steinbach, Monte Meyer and Philip Smith of Shining Star Consulting, and myself are still working on closing the books for Fiscal Year 2019-20 and we are correcting several accounting errors as well as working on other improvements that will make the books easier to understand and more transparent.

I have attached to this report a Revenue and Expense Versus Budget Report for July 2020 as well as a Balance Sheet as of July 31, 2020. Unfortunately, we have not yet entered the budget numbers for Fiscal Year 2020-21 in the financial system, so it is not possible to give a line by line actual versus budget numbers for July, 2020. There are several worth noting on the Revenue and Expense Report that I have highlighted in yellow: On the Revenue side:

- Pledge income for July 2020 is \$ 11,730, which is behind budget by \$15,353. I anticipate that pledges will continue to be a challenge this year as they were last, and we will need to muster resources to address this problem.
- Our school rental income is \$ 27,132 which is \$2,007 better than budget.
- In July, we had capital gains on endowment and investment funds of \$48,846.
- In summary, July Total Revenue was \$ 94,271, which is \$29,014 more than budgeted.

On the Expense side:

- July 2020 Salary and Wages were under budget by \$ 22,683 owing to the ministerial transition.
- Most other expenses are at or below budget. There have been substantial decreases in utilities and program expenses since we are not having programs and are not using the building.
- In summary, July 2020 Expenses were \$ 15,1403 less than budgeted.

The bottom line is that the July 2020 Surplus is \$58,162, which is \$66,207 better than budgeted,

There are also a couple of points worth noting in the Balance Sheet:

- At the end of July, the Mechanics Checking account is now \$ 261,858 and the Mechanics Savings account is \$ 402,636, which includes the \$ 250,000 Bequest from the Ann Lane estate. Hence, our cash reserves at the end of July were a whopping \$ 402,386.
- UUA Board Designated Endowment is now at \$813,697
