#### **DISCUSSION/ACTION ITEMS**

## **Briefing from the Widening the Circle of Concern Task Force**

Beth thanked all members of the task force (including those listed above plus Board members Cordell, Elaine and Helen) and asked Helen to lead the presentation, a "preview" or "warm-up" for the September meeting. Each introduced themselves, mentioned what other groups at UUCB they are involved in, and what impact their work on the task force has had on them. Helen described the Social Justice presentation at General Assembly, "Periwinkles and More." Victoria summarized the process the task force went through, establishing focus areas (Youth, Connections, Education for Liberation, Accountability, Living Our Values, Resources, Arts & Culture, Worship), meeting biweekly, creating a safe place for discomfort, not rushing, accumulating Google docs, making a few recommendations along the way, and drafting the final report.

Comments and questions:

Some "how-to" handouts and sessions would be useful

Board should do some prioritizing among recommendations

Appreciation, looking forward to actualizing

How can the rest of the congregation "catch up"? "Join in wherever you are and we'll figure it out together."

Encourage all to read the UUA report, absorb, discuss in small groups

Report will suggest some starting places for a process

Appreciation for leadership by Helen and Victoria

They started out thinking it would only take a couple of months to read and discuss the report, but it took 24 meetings

It was painful at times and being held with empathy and compassion was healing—how to replicate throughout the congregation?

They identified specific passages individually to read aloud and discuss
