Dear Members of UUCB,

Over the past year, the UUCB community has engaged in information gathering, sharing, and exploration to develop a proposal for our Freestone retreat property. Designed and led by Rev. Michelle, this deliberative process sought to bring a variety of perspectives together to find an acceptable congregational answer to the question: ***What next for Freestone?***

The outcome of the process is the [proposed resolution](#) approved by the Board of Trustees for a congregational vote. This resolution lays out a phased path towards safe, healthy and financially sustainable use of Freestone, while also recognizing the challenges in getting there. The milestones along this path for fundraising and improvements, and requirements for financial sustainability, permissible use, and protection against liability, are intended for UUCB to measure and determine, over time, whether or not we are successful.

Does the congregation wish for UUCB to embark upon the path for Freestone? That is the question before you in the vote on March 26, 2023.

- YES VOTE on Resolution No. 22-1 = *Keep Freestone under the described phased and conditional plan to renovate and reopen (see [Resolution language here](#))*
- NO VOTE on Resolution No 22-1 = *The Board of Trustees will take steps to sell the Freestone property*
- Motion passage = Majority (50%+1) of the votes cast

Due to the significant importance and interest in the final vote on Freestone, the Board of Trustees has proposed a congregational motion to extend the time to vote on the final motion, for members not present in person, until April 1. This motion will be considered at the meeting prior to deliberation on Resolution No. 22-1.
