A quorum being present, the meeting was called to order by Helen Tinsley-Jones, co-president, at 7:20__p.m. Cordell did the chalice lighting and reading, Michael read the Board covenant, Selene read the land acknowledgement, and David read the Widening the Circle Vision Statement.

MINISTER'S REPORT

Heaven Walker will leave her position as Director Family Ministry and Lifelong Learning at the end of June to pursue becoming a chaplain. Reverend Marcus has scheduled a meeting next week for the people most involved with Family Ministry. By the end of February, Reverend Marcus plans to have put together a hiring team, the composition of which he will share at the

March Board meeting. March is the right time to get search for a new FM Director since this is the time when religious professionals are most likely to be looking for new positions.

Update on the installation: The following previous UUCB ministers will be in attendance: Barbara & Bill Hamilton-Holway, and Chris Holton Jablonski.

The Stewardship kick-off is on Sunday March 3rd.

Tess and Rev. Marcus have begun working on the budget for FY24-25. They reviewed staff salaries in the context of UUA's salary guidelines. UUCB has some catching up to do for some positions.

Networking with local clergy is one of Reverend Marcus' goals. Toward that end, he attended a "Faith and Justice" which brings progressive faith leaders together. In addition, UUCB will host GRIP's annual meeting next month, providing another opportunity to connect. Marcus was invited to be the chaplain for a trip to Tijuana in early April with other congregations. The goal of the trip will be to build a home in a few days.

Michael Dewitt reported 50 people came to the Freestone Committee's film and dinner fundraiser. He also proposed the idea of using the UUCB church parking lot as a distribution center for the Food Bank of Contra Costa and Solano.

DISCUSSION/ACTION ITEMS

a. Annual Report – Tess Snook O'Riva

Tess postponed sharing Annual report with the Board until the March Board meeting after it has been reviewed by the Finance Committee. The Annual Report is an internally-developed document and communication to the congregation and community. Tess's goal is to present future annual reports in the fall.

b. Governance Manual Task Force: Approval of updated Governance Manual – Beth

Pollard and Kay Fairwell

Kay shared three additional proposed revisions. These proposed revisions are in addition the revisions presented at the January Board meeting. The 3 additional revisions are as follows: 1. Clarifying language regarding endowment provisions. 2. Stated that employees may use the grievance process for termination actions. 3. Added policy language supporting the Good Neighbor donation practice and Christmas Eve plate donations going to the Minister's Discretionary Fund. Kay and Beth reminded us that the Governance Manual is a living document and can be updated at any time.

Motion: Pier made a motion to approve the revisions to the Governance Manual as submitted in the board packet. Michael seconded. The **motion passed** unanimously.

c. Board Process for New Members – Helen Tinsley-Jones and Pier Sun Ho

At a previous Board Meeting, the Membership Co-Chairs, Lonnie Moseley and Victoria Bowen, requested the following actions to help welcome new UUCB members and introduce them to the Board of Trustees:

- 1. A Certificate of Membership be mailed to each new member. UCCB Administrator Janae has begun doing this.
- 2. Every 6 months, the Board would invite new members to a Board Meeting where they would be introduced and welcomed by the Board. Selene agreed to send the email invites. We will begin this tradition at the March 6, 2024 Board Meeting

Discussion:

Several members stated they thought it was a good idea.

There was a suggestion that board members reach out by phone to new members to welcome them. Each new member would be assigned to an individual board member. There is currently a backlog of new members, since we are going to start with welcoming all the new members since January 1, 2023, but in the future, it is anticipated that there would usually be no more than one new member for each board member to call. This task would need to be added as a standing discussion item in order to assign new members. There was discussion regarding creating a list of "talking points" including mentioning ways the new member could become more involved. Michael will reach out to Victoria to see what Membership already shares with new members. Rev. Marcus stated that he and Charis recently created a brochure that outlines church programs and activities.

d. Transylvania Partner Church Meetings – Anne Greenwood

Anne Greenwood provided a report on the January 20, 2024 meeting with the Church Council of UUCB's partner church in Transylvania, Reverend Marcus along with some members of the Partner Church Committee, and representative members of the UUCB Board of Trustees. Anne's written report will be included in the March Beacon and next week's "The Week Ahead." Anne is planning a trip to Transylvaniáz and encouraged all interested parties to join her. Anne is interested in establishing quarterly calls with the Church Council of our Partner Church, as well as the possibility of bringing their minister and some members to Berkeley to visit. Anne will work with Marta to have more information about our Partner Church program shared with the Program Council.

Question: Is there still a Balázs scholar from Transylvania?

Answer: The Balázs scholar program ended due to changes in Starr King, as well as changes in the building that had housed the visiting scholars. There is still work being done on the archives but the visiting minister program has stopped.

e. Beacon Article - Pier Sun Ho

Will set up a new rotation for board tasks starting March 2024.

Kay reported that \$120 was given to each UUCB staff member as part of our Staff Appreciation effort. Helen, Pier, and Kay went to the staff meeting to present the financial gifts and to express appreciation.

Stewardship Committee – Selene and Kay encourage board members to pledge early.

RE: Report for Board Meeting – March 6, 2024

Update on Tax Filings:

The Calkins Trust tax returns for 2023 were filed this month. There were no taxes, penalties, or interest due with the return.

The Pooled Income Fund trust returns, including the information Form 5227, were filed this month for years 2020, 2021, and 2022. No taxes, penalties or interest were paid with the returns, however it remains possible that penalties will be assessed later. The CPA firm (Byrne Seligman) is currently finishing work on the 2023 returns for the Pooled Income Fund.

The Finance Committee is considering a draft policy and procedure memo that I wrote, to help ensure that we remain in compliance with our tax filings going forward.

Financial Review for the year ended June 30, 2023

Our staff and accounting contractor are compiling the documents we'll need for our financial statement review for last fiscal year. Tess has reached out to Healy and Associates, our auditors, to schedule the review. They have quoted a fee of \$10K for the review.

Financial Reports

Budget Comparison Report, Current year-to-date (7/1/23 – 1/31/2024):

As with last month's report, the following "Unrestricted/Budgeted Items Only" excludes restricted revenues and those expenses that are covered by special restricted funds. Also excluded are depreciation, and realized/unrealized gains on our endowment and investment accounts. (Note, the Finance Committee reviews a report of "All Funds" including TRNA activity).

- Revenue is running at or ahead of budget in most categories. Although current year pledge income appears behind budget by \$15K, the collection of prior year pledges is running \$27K above the budget target. Other revenue categories are are generally on target.
- Salaries and benefits costs, when considered on a combined basis, are running just slightly over budget (\$4.5K over).
- Professional development is over budget by \$5K and includes training and costs of setting up our new minister's office.
- Utilities on a combined basis are currently running \$5K under budget.
- Accounting services is running over by \$9K. We project that by the end of the fiscal year, we will run over by approx. \$15K. The year-to-date costs have been running high due to catching up on a big backlog. In addition, we'll be adding the \$10K financial statement review costs here.
- Utilities are running under budget by \$6K, which is good news as we're mostly through the coldest part of our year.
- Overall, the remaining expenses are on track.

FOC Report Outline

- Update on the status of the Conservation Easement application for Parcels 1 and 2 and a large part of Parcel 4 of the Freestone properties (information only)
- Update on listing Parcels 1 and 2 of the Freestone properties with Coldwell Banker Realtors in Sebastopol (information only)

Conservation Easement (CE) Application

- The Freestone Committee applied for an Agricultural Land Easement (ALE) 2024 grant through the Natural Resources Conservation Service (NRCS) department of the US Department of Agriculture. The proposed easement included Parcels 1 and 2 and a large portion of Parcel 4 where the dome resides.
- The Conservation Easement application was denied on February 20, 2024 on the grounds that the Freestone property has never been used for agricultural purposes.
- The Freestone Committee is in the process of appealing and has until March 8 to file an appeal.

Conservation Easement (CE) Timeline

- The conservation easement application was submitted on December 13, 2023
- Revisions to the application were required and those were filed on February 9, 2024
- The application was denied on February 20, 2024
- The Freestone Committee is considering filing an appeal which would be due on March 8, 2024
- No other Conservation Easements are being pursued at this time

Listing of Parcels 1 and 2

- The UUCB Board of Trustees approved the listing of Parcels 1 and 2 of the Freestone properties at the January 10, 2024 Board of Trustees meeting
- The Freestone Committee negotiated a listing agreement for Parcels 1 and 2 of the Freestone properties with Realtors Laura Richards and Kent Byers of Coldwell Banker in Sebastopol
- Parcels 1 and 2 were listed in MLS on February 23, 2024
- The list price for both Parcels is \$300,000

connected, we've learned to be quite nimble. Our virtual footprint has expanded—the technical skills of staff and members now allow for smooth Zooming and live-streaming of services and events. The Membership Team predicts that the number of newcomers to service this year will far exceed the count for all of 2022.

Our commitment to Social Justice remains strong, as is reflected in the actions and activities of the Widening the Circle of Concern Committee of the Board and the Social Justice Council, which houses a number of groups dedicated to confronting racism and oppression, advocating for climate justice and engaging in community projects and events.

We've emerged from the financial pickle of previous years. Our financial situation is strong, and the budget is balanced. We're now paying our fair share as members of the UUA. In February, member Jane Lundin generously gifted UUCB with the extraordinary donation of a house in El Cerrito, to be used as a parsonage or rental property.

In March, guided by Rev. Michelle's thoughtful, well-crafted and inclusive Freestone process, the congregation came together to discuss our differences in a restorative way, leading to the approval of Resolution 22-1, which is creating a path for Freestone's future.

On May 7, this congregation, by unanimous vote, called Rev. Marcus Liefert to be our next called minister. Thunderous applause greeted Rev. Marcus as he entered the Social Hall after the vote count. We all said a resounding, "YES!"

UUCB's optimism is buoyed by the phenomenal accomplishments of two UUCB groups, each formed for specific, time-limited tasks – the Ministerial Search Committee and the Opening Task Force – as well as by amazing work of many UUCB members and groups, which number somewhere between 50 and 80, depending on how you aggregate or disaggregate them.

In the spirit of UUCB's moving into its vibrant future, the Board, at its May meeting, approved goals and priorities for 2023-2024, which are represented in the schema at the top of the report. The flower is nested in and encircled by the overarching themes of caring for ourselves and others, having impact in the world and growth, as we widen our circle and adapt to and meet challenges and needed changes. The flower petals display the Board's missions-spiritual care and growth, championing for love and justice, courageous leadership, stewardship and sustainability, and connection and community. The missions on the petals are aspirational and will guide us in our work over this next church year. And at the center of it all is our grounding goal-beloved community. The goals are listed in the box to the side.

This is in alignment with the direction in which UUA is also moving.

Our congregation is bound together and guided by love, covenant, and a deep commitment to our values and to one another. So while we're likely to slip and stumble, and gripe and grumble as we move into our future, we'll do it together, always siding with love.

Administrative Year in Review


This has been a busy and productive year for our organization, as we have improved our administrative systems, processes, and policies to support the mission and vision or UUCB. Some of the highlights of our staff accomplishments from July 1, 222 through June 30, 2023, are:

- After being vandalized three times, we installed a robust sign holder to house our Black Lives Matter banner and event announcements at the corner of Moeser and Arlington.
- We hired a new Facilities Assistant after a long search and welcomed him to our team!
- We applied for and received a \$20,000 grant from the Unitarian Universalist Association's Disaster Relief Fund. Five giant trees fell, and more were dangerously close to falling.
- We hired a new accounting firm to bring all our financial reports up to date and review our policies and practices and help us be continually audit-ready.
- We hired a new Information Technology consultant to assess our infrastructure, improve our network, and set up secure VPN services for remote workers and consultants. We also upgraded the AV in the Sanctuary and Fireside Rooms.
- We developed and adopted a new employee handbook that clarified our organizational values, policies, and procedures.
- We welcomed the Kensington Fire Protection District on site, housing their temporary fire station in our lower parking lot through September 2024.
- We onboarded a full-time Director of Family Ministry.
- We implemented a new project management system to keep all facilities requests, maintenance calendars, rentals, and other projects in order.
- We implemented a Partnership Program, officially designating the Kensington Symphony Orchestra as our orchestra-in-residence, and solidifying our relationship with the American Tongan Church, Contra Costa Chorale, East Bay Amateur Radio Club, and The Good Earth School, among others.

Most important to our church and mission, the congregation chose a new settled minister, Rev. Marcus Liefert! Staff are very happy with their choice, and we look forward to all we will accomplish together!

Worship Associates

The 2022-23 church year proved to be quite active for the Worship Associate (WA) group, assisting in the production of 53 worship services. Typically, one worship associate (WA) is assigned to help with each worship service, although on some occasions two or more have participated in a single service. The work of the WA in a given week begins on Monday, reaching out to all of the participants to make sure all roles are filled (including the AV Tech team members) and all elements are set to come together. The worship associate monitors the progression of the Order of



Service (OOS) on a collective Google Drive, writing in content as appropriate, until it is completed, usually by Friday afternoon. Then, the WA syncs the OOS with the AV Cue Sheet which serves as a guide to the Slide Producer in slide preparation and to the AV Tech team on Sunday Morning in managing livestream and sound broadcasting. All of this is the WA's behind-the-scenes work. Then, during the service, the WA participates on the chancel, presenting segments from the lectern, often giving a reading or a personal reflection in coordination with the minister. During the course of the year, ten WA's were active:

Andrea and Bill Brown left on maternity/paternity leave in October, Robin Cooper and Jason Russell joined in September, and Smiley Nelson in November. Ginger Frederick joined in the New Year, and Dayana Claghorn last served in the January 1st service. Through the year Karen Elliott served as our lead WA, calling and leading monthly meetings and was heartedly relied on for backup support and problem-solving.

There were a number of memorable services during the year-such as special services for Thanksgiving Day, Winter Solstice, and Christmas Day. The Candlelight Christmas Eve service was notable for its emphasis on the feminine dimensions of the Jesus story. Two services employed a modified Lectio Divina format, featuring poetry of Mary Oliver and Rumi. The New Year's Day and the Rumi Lectio Divina services were all-WA led.



Pastoral Care

Pastoral Associates and other lay members who join us in pastoral care are substantial sources of connections of support, comfort and healing and embody our important Mission of "creating loving community." We often work confidentially and are seldom in the limelight.

In church publications and on our UUCB website, our "advertisement" asks: "Pastoral Care Need? If you or a UUCB congregant you know is sick, hospitalized, recovering, grieving or otherwise in need of attention and support, please email us at pastoralcare@uucb.org

Professional ministerial responses are provided by Revs. Marcus Leifert, Sue Magidson, and Jane Ramsey. During her Interim, Rev. Michelle Collins met regularly to help support and train us, in addition to her own ministerial duties, as does Rev. Marcus now. Pastoral Associates, as lay members, provide supplemental and complementary pastoral care, through calls, visits, notes of remembrance and special projects.

Since September 2022, we have:

- Followed 40+ individuals and 5 couples and families and supported them with calls, visits, and notes of support
- Provided rides to church
- Helped spread word of injury, illness, transition and/or bereavement through supercards, Discuss List and publication notices, with permission of those involved. Congregants made aware of the concerns and joys of others may then also reach out to them.

- Called regularly 78 individuals and 12 couples 80 and better
- Co-sponsored, with Family Ministry, holiday remembrances of cards and decorative bags filled with candy and cookies, cards and messages created by our youth and older volunteers, for those 80 and better and those younger people and families for whom 2022 had been a challenging year

Transylvanian Partner Church Committee

The Transylvanian Partner Church Committee fulfilled one of its primary goals by remitting scholarship funds from the Village Education Fund at UUCB to our partners in Homoródújfalu,

Anne Greenwood visited Homoródújfalu, Romania in September, 2023. This was our first visit since 2016. Anne attended the convocation of the International Association for Religious Freedom which was held in Kolozsvár, Romania. The minister from the village, Gyerő Attila, came to Kolozsvár to bring Anne back to Homoródújfalu. While in the village, Anne met with the recipients of scholarships from the Village Education Fund. Our 12 different Chalice Circles, run by 12 facilitators, fostered significant connections between close to 100 participants. We found that, as ever, both newcomers and long-time UUCB members long for that sense of connection that is nurtured in a small group.

Family Ministry

This year saw a lot of happenings in Family Ministry! First, our new Director of Family Ministry, Heaven Walker, has now been with us for a full year. She has been learning the ropes and contributing a new perspective at UUCB. She started in May 2022 and helped out with several celebrations over that summer: a 4th of July gathering, a youth movie night, and an all ages potluck.

We ran Religious Exploration classes throughout the year. In addition, the Coming of Age program was held this

year, and culminated in a beautiful service run entirely by the youth in the program. We also offered an impressive four levels of OWL (Our Whole Lives Sexuality Education): K-1, 4-6, 7-9, and Adult! The Youth Group continues to have strong attendance, and had monthly gatherings throughout the year.



We provided support for families. We held monthly Parents Night Out events that were open to the wider community in addition to UUCB members. Once we got the word out, the available slots were filled every month! This is clearly a much-needed service. We also held a Parent/Grandparent Discussion Group monthly. There was a chalice circle for parents with teens as well.

Next year we hope to provide more training for our developing Director of Family Ministry, involve kids more in church services, provide more opportunities for kids to participate in community service, and provide more opportunities for families to build community together.

Stewardship

The members of the Stewardship Committee: Cynthia Asprodites, Lynne Cahoon, Selene Fabiano (Chair), Kay Fairwell, Lisa Maynard, Dave Roberts (board liaison), Karen Tripp, Anne Wardell, Reverend Michelle Collins, and Executive Director Tess O'Riva. Although not committee members, Patrick Cullinane and Bob Adams helped with pledge reminder phone calls and emails.

We met weekly from November through the beginning of May, with a few weeks off in December. Our initial Pledge goal was \$445,000. The FY23-24 budget included \$435,000. The pledge total as of 5/20/23: \$432,095, with 141 pledges from 180 members and 2 friends. The Finance Committee expressed confidence that the 2023 pledge goal will be met.

Stewardship Committee Activities

- 1. Theme Song: "We are Building a New Way"
- 2. Kick-Off Event:
 - a. The Kick-Off Event was the result of the leadership of Lisa Maynard and Karen Tripp.
 - b. Representatives from all the major church program areas were invited to participate.
 - c. Approximately 16 programs set up table displays.
 - d.A luncheon was served. Approximately 80 people attended.
 - e. The goals of the event were:
 - i. Help the UUCB community reconnect
 - ii. Showcase UUCB's many programs and allow them to recruit volunteers.
 - iii. Create a fun and inclusive event for children and adults.
- **3.**Outreach to Regular Pledgers. We reached out to the 70 households that pledged more than \$800 in 2022 to connect and encourage them to pledge. We attempted to connect by phone and if that didn't work, we reached out by email. As of 5/12/23, 87% of these contacts resulted in a pledge.
- **4.** Outreach to New Members: We reached out to 11 new members to provide education and support regarding pledging.
- **5.** Lego Chalice Thermometer: Rev. Michelle created a Lego chalice to represent our pledge goal. Each week, Legos were added to show progress towards the goal.
- **6.** Congregant Stewardship Reflections: during Sunday Services in February and March, a UUCB congregant shared what UUCB means to them.
- 7. Celebration Sunday. The pledge total was shared with the congregation and cake was served.

Lessons Learned

- 1. Make the campaign fun!
- 2. Work with Tess to establish a realistic pledge goal.
- 3. Add Stewardship events to the church calendar as early as possible.
- 4. Start early to coordinate activities with RE.
- 5. Enlist UUCB members who aren't on the committee to help make pledge calls.



Membership

Our Membership work this year was characterized by a full transition from pandemic restrictions to in-person services and meetings.

We held four Membership Informational Meetings, all in person. The **Co-Chairs, Lonnie Moseley** and **Victoria Bowen**, hosted. Our resident UU historian, Rev. Jay Atkinson, provided leadership and history. Rev. Michelle Collins, Interim, joined as able. The meetings provided participants with an opportunity to share their journey, learn about UU and UUCB and meet lay leaders and ministers in a small group environment with lunch served.

We held two "Welcome New Members" rituals during services on October 16, 2022 and on April 23, 2023. This ceremony gives the new members the opportunity to be formally welcomed by and into the congregation. We give each new member a rose, so congregants can greet them individually afterwards.

A high profile function of Membership is our welcoming at the door each Sunday. This year we transitioned from the Re-Opening Task Force greeting attendees to a robust Welcome Team with fewer Covid protocols needed. As the Task Force wound down, we successfully recruited members to welcome. In addition to the co-chairs, Welcomers are **Susan Blair**, **Debi Clifford**, **Christina Creveling**, joined in recent months by **Paul Hudson** and **Diana Smith**. The Welcome Team greets new attendees and long time congregants, assists with name badges, directs newcomers, captures their contact information and answers questions. We invite all to stay after the service for Coffee Hour. We have three-four members in this role each week and staff up for special events such as Easter, the Doctors of Durability service, and Candidating Week.

On June 10, 2023, Lonnie and Victoria hosted a thank you gathering at Victoria's home. We served refreshments, presented an overview of the year's work, solicited feedback and thanked them for their contribution to the church. We decided to make this an annual celebration going forward!

One new initiative is an effort to formally reach out to new members some months after they signed the book. **Lynn Hammond** has volunteered to take on this work. So far, we have drafted a script for email and phone calls and have identified several new members for the outreach. We will sum up the outreach efficacy and expand this project if indicated.

In addition, we receive many contacts via our website Newcomer form, which we answer promptly. We work closely with office staff especially **Charis Domador** and **Caitlyn Vincent** for Newcomer and New Member support. Membership thanks these staff members for their creativity, consistency and patience. We look forward to continuing and expanding our membership activities under the leadership of our newly settled minister, Rev. Marcus Liefert.



From July 2022 through June 2023 choir moved to meeting again in person several Thursday evenings per month. All singers remained masked throughout rehearsal and while in the church building. Bryan resumed in person concerts, recitals, and also arranged special music for Sunday services. He continued to recruit song leaders in singing hymns during Sunday services. The choir also began singing in church services a few times per month. Choir members continued to be masked. Katie Lipka continued her excellent work directing the children's choir.

Our Music Director, Bryan Baker continues to bring us spiritually uplifting and beautiful music from many musical traditions, so that we can continue to provide a musical ministry to the church congregation and wider church community.

During the period of 2022-2023 Luminescence raised \$10,870.17 (\$12,500 budgeted) for the church's general fund through concerts such as Bryan Baker and Friends, the then resumed in person Sing Along Messiah, Barry Zuckerman & Michelle Voileque recital, and an enthusiastically attended Love Songs and Chocolate.

From 2019 until now, probably because of the Pandemic, Luminescence lost almost two thirds of its members. As the new year begins, we are slowly bringing back many of our excellent singers and hope new members will join us. We are excited and expect the coming year will bring us all together once again to share amazing music with the church community.

Social Justice Council

Purpose

The purpose of the Social Justice Council is to curate and focus the justice making of UUCB to be more impactful. The Council meets every second Wednesday at 7 pm on Zoom to hear reports of the many programs as well as make plans for events and outreach. We run a Social Justice Table every Sunday and during special events to inform people about what's happening and opportunities for participation.

Actions

- The Honoring Indigenous Peoples (HIP) Group led a summer reading and discussion group about the book *Braiding Sweetgrass*, then presented an LFDMC program based on the book, and planted a Three Sisters Garden.
- In November the SJC partnered with other UUCB groups to replace and restore the Black Lives Matter sign on Arlington at Moeser that had been vandalized.
- In December's Winter Sharing for Unhoused People, we collected tarps and other survival equipment to share with the clients of Albany Thrives Together.

POCC

The People of Color Caucus (POCC) met every month this year and helped to support one another during difficult times, shared personal cultural histories and moments of resilience and created "cultural moments" for congregants: Hoppin John potluck and honoring of the Chinese Lunar New Year. The POCC also produced and led a profound Worship Service during February's Black History Month in which all programs of UUCB participated and also special guest, Bishop Annie Green from The City of the Lord Zion of Oakland church. The POCC is chaired by Helen Tinsley-Jones and Lonnie Moseley.

GRIP

In addition to participating in the Harmony Walk - Greater Richmond's Interfaith Program (GRIP)'s annual fundraiser- and our Good Neighbor program offering much needed financial support to GRIP, on the fourth Tuesday of every month, volunteers from UUCB prepare and serve lunch to almost 100 homeless, hungry, and other disadvantaged people associated with the shelter.

WOWS

WOWS (Working to Overcome White Supremacy) hosted a number of presentations in 2022-2023, such as talks on racism in housing; Nicole Hannah-Jones's docuseries, *The 1619 Project*; the work of Speak at Albany High School; microaggressions; and "American Democracy without White Supremacy: Real, Aspirational or Hype?" They also continued to share Moments of Awareness of Unconscious Bias (MAUBs) and Moments of Illumination (MOIs).

CIC

This year the **Climate Justice Committee (CJC)** researched the UUA Green Sanctuary process, hosted a screening of the inspiring and hopeful environmental film 2040 in honor of Earth Day, encouraged recycling and composting on church grounds, and provided opportunities for the congregation to learn about climate and other environmental issues and to take action. About 60 people attended the 2040 film, which we followed with a lively and engaged small group discussion. Several members of the CJC co-led a Cerrito Creek clean up with members of the Family Ministry program. We encouraged members of the congregation to use the Climate Action Now app, which facilitates taking effective advocacy actions. We have a "UUCB team" on the CAN app, consisting of 15 people who have taken one or more advocacy actions. Some of these members have taken literally thousands of actions. This year, for the first time, we also nominated several local organizations focused on environmental justice to the Good Neighbor program, and many of those were chosen.



Adult Education & Exploration

Applied UU Buddhist Sangha

This past year we met every Tuesday for two hours on Zoom. We meditated for fifteen minutes, shared about the relevance to our lives of Buddhist readings and ended with Metta affirmations. We currently have eight members who have benefited from these experiences which affirm the values of beloved community. Leader Lynnette Delgado.

Textiles And Art Group

Textiles And Art Group was formed at the end of the church year 2023 with much support from UUCB congregants who enjoy creative endeavors, engaging in designing and making textiles and art. We presently meet twice a month, pursuing individual and group projects with encouragement, laughter and sharing of ideas. Leader Karen Tripp.

Wednesday Walt and Talk

The Wednesday Walk and Talk group is open to all and has been walking on Wednesday mornings for more than ten years. Attendance ranges from two to six or more people. Heaven Walker joined us on one walk, and a special Monday walk with Rev. Marcus took place during his Candidating Week. Leader Ann Harlow.

Women's Book Group

We have come to know each other deeply through our discussion of books and the relationships between the world, history, and our own lives. The love and trust we have developed over time allow us to explore difficult topics such as social issues, human-caused destruction, and our mortality. We draw comfort and hope from addressing these topics together. The most recent books have been: Being Mortal by Atul Gawande, Cloud Cuckoo Land by Anthony Doerr, The Overstory by Richard Powers. Leaders Lisa Maynard and Karen Tripp.

Adult Education & Exploration cont'd

Women's Meditation Group

Evelie Delfino Såles Posch stepped up to organize the Women's Meditation Group. They were joined by several new members including Rev Marcus' mothers. All the women continued to meet weekly on Monday mornings, and offered both in-person and virtual opportunities to practice "Mettā/Loving-kindness." Facilitation each week rotated among all the women so that all voices would be heard in myriad beautiful and beneficial ways.

Write For Your Life

Write For Your Life, a creation of Beth Glick-Rieman and continued by Kit Hewitt, continues to Zoom every Monday to write meditatively on life, the universe and anything else that is on our minds. Leader Kit Hewitt.

Humanist Connections

The Humanist Connections Discussion group has continued to meet weekly since the last report. During COVID all meetings were online via Zoom. When the church began meeting on campus again, we started meeting at church once a month, with the other 3 or 4 meetings a month still by Zoom. We have some members living outside the Bay Area, and others sufficiently incapacitated that a meeting via Zoom is the only realistic way to attend. We have averaged 12 to 15 attendees per meeting.

We continue to address a wide array of topics, with the 4th Principle of UU being our motto. The speaker introduces the topic for 10-15 minutes, then the discussion is opened to all, with the speaker moderating. Topics for the next month are suggested and selected by vote once a month.

This year we have discussed several aspects of artificial intelligence and Chat GPT4 and their implications for our lives and values, political issues, threats to the vote, new developments in science, ethical issues and values, etc. Whatever is prominent in the thinking of attendees can become a potential topic for discussion. Personal Theology

Overall, the Personal Theology program for UUCB was successful despite ongoing technical issues. Starting in September 2022, efforts were made to provide hybrid presentations i.e., Zoom and inperson, broadcast from the Fireside Room. None of the efforts were entirely successful due to poor internet connectivity. To make a hybrid format work, the internet issues need to be solved*.

We provided 15 sessions and came in under budget. Attendance ranged from 22 to 75 with an average of 35-40. Our speakers covered a variety of topics such as poetry and creativity, Rev. Bernard Loomer and Process Theology, Our Whole Lives for adults, and native American spirituality and sweat lodges. Attendants came from several states plus a few foreign countries thanks to the Zoom format. Due to several important issues that the church membership needed to address, the number of Sundays available for Personal Theology programs was reduced. We hope to increase the number of programs again starting in September 2023.

We are encouraged by the selection of Rev. Marcus Liefert as our new settled minister starting later in 2023. Several individuals have expressed an interest in providing presentations starting in September. Also, several members have made suggestions for future speakers/topics and have provided references for these as well.

We also want to thank Rev. Michelle Collins for her strong support and participation over the last 3 years. Her input as well as the presentations she gave were invaluable to the success of the Personal Theology program during the tumult of Covid. Also, a special thank you to Beth Jerde, Lonnie Moseley, and Cordell Sloan—we couldn't have done it without you!

Lawrence Lecture

The Lawrence Lecture Series, established in 1977, aims to provide a public forum for inquiry into the nature and relevancy of religion (institutionally, philosophically, or as an ethical force) in a world of accelerating technological and social change, and conflicting social values. Additionally, this event is designed to attract favorable public attention to a liberal religious presence in the community.

The committee started 2022 determined to bring back the live event in our Sanctuary, after two years of interruption by the Covid pandemic. We were, perhaps, overly optimistic, as the pandemic kept continuing into the Fall.

We were dismayed early on by the very steep fees of speakers we were interested in inviting. However, by using the progressive speaker's bureau SpeakOut, we found a range of impressive speakers for more reasonable amounts. We chose Keith Knight, award-winning cartoonist of the "K Chronicles" and "The Knight Life". Musician, educator, and co-creator of Hulu TV's "Woke", his work addresses social and racial justice issues with humor and humanity, as well as outrage and anger.

Mr. Knight was a dynamic speaker with a well-organized visual presentation and a Q & A session following. Many attendees congratulated the committee afterwards; emails over the next days included "excellent speaker", " FABULOUS", and other positive feedback. Mr. Knight sold books and artwork afterwards, continuing the conversation for some time.

As has become the 'new norm,' we livestreamed the event, which allowed those with mobility issues, night-time travel issues and Covid concerns to participate. The Committee is indebted to David Rosales for stepping in on short notice to make it work so smoothly and very glad he has joined us to work on this next year's Lecture.

Our expenses were increased by a travel delay for the speaker and the live stream costs. The honorarium was \$5000, travel and hotel costs about \$1600, staff time and advertising a total of \$760, with an income of \$1545 in ticket sales and donations. We basically lost \$6000 and that is a concern for the future of the Endowment Account, even if it is at a healthy level of \$67,000. Despite protocols about distance in the pews and the wearing of masks, the attendance of about 75 was not what we had hoped for. We did have, however, a good proportion of the audience who were new to UUCB, always a goal of the Lawrence Lecture.

Beginning our work again for the 2023 Lecture, we are proposing to offer an honorarium that we feel we can afford (as well as travel and other expenses) as a negotiation with speakers; the caliber and history of our speakers should be as much of an attraction as our funds. We have actively broadened our efforts to promote the awareness of the Lecture within all the groups and activities at UUCB. We also want to give the Lawrence Lecture more presence online with an archive of speakers recordings available to the public in the future.

Chair Camille Parker, Chair and Treasurer, Katie Lipka; Secretary, David Rosales; members, Jim Acock, Christina Creveling and (formerly) Jack Duggan; Melissa James (UUA Pacific Western Region) and Rev. Marcus Leifert, UUCB are included as titular members.



Landscape Team


The small but mighty Landscape Team meets monthly to discuss the best way to make the church grounds look good, and be safe. Our overriding concept is "to care properly for the land," which at UUCB is almost 9 acres.

Our activities this last year included:

- Maintaining attractive plantings on the terrace and around the perimeter of the church. Maintaining drip irrigation systems to help with the watering of landscape plants.
- Responding to 5 trees that fell in the winter storms of 2023. There were 3 large
 Monterey pines that fell, and also a Douglas fir tree fell from the church property into a
 neighbor's yard, and a Strawberry madrone tree was uprooted in the parking lot. Also a
 large sick Monterey pine needed to be removed by an arborist because it might have
 fallen toward the pre-school, this took an emergency order with Contra Costa County.
- We organized monthly Work Parties that did activities like weeding and spreading wood chips in the parking lot islands, removing bushes blocking views toward the bay, removing low hanging tree branches blocking tall fire trucks or our fire hydrants.
- We participated in the annual weed whipping of vegetation to provide fire fuel management, as required by the fire department.
- We sponsored some nature walks for Earth Day, UUCB birding and native plants walk that finished at the successful Great Horned Owl nest with 2 owlets on the church building.
- We consulted with the Honoring Indigenous Peoples Group and others on building the successful 3-Sisters garden.

This coming year we will continue to plan the best care for the church land, which will include tree maintenance, including arborist action on the remaining sick and hazardous Monterey pine trees. We need to select and replant some trees in the parking lot islands, install some wooden steps for the steep trail to East hill overlooking Wildcat Canyon, request installation of a camera for the UUCB Great Horned owl's nest, and just respond to the various issues that come up.

If you would like to participate with the fun UUCB Landscape Team, you are encouraged to come to a work party or discuss with any of the members. There are so many projects that need attention and contribute to the health of our church community.





Building & Grounds Committee

The building and grounds committee meets monthly and supports the Executive Director and the Board of Trustees in prioritizing, analyzing and implementing projects that support the mission of the church in providing safe, welcoming, functional and aesthetically pleasing spaces.

During the 2022-23 fiscal year, we worked on the following major programs and many smaller ones:



- Developed a long-range facilities plan and issued a report identifying physical needs and preliminary budget cost estimates, which total close to \$2M.
- Sponsored numerous volunteer work parties, which accomplished landscape upgrades and many miscellaneous beautification tasks, both inside and out.
- Completed the installation and commissioning of the computerized HVAC control system, controlling the temperature and fresh air in the ventilation systems for the Sanctuary and Social Hall.
- Analyzed and recommended the rental of site space and utility connections to the Kensington Fire Department for a temporary fire station.
- Authorized and accepted schematic design studies for all the HVAC systems on campus. The designs are ready for funded HVAC projects.
- Authorized and accepted a schematic design study for a new, enlarged electrical system, which will replace outdated switchgear and upgrade our service to enable a future all-electric campus. The schematic design is ready for a funded project.
- Refreshed the Atrium bathrooms and converted them to be gender neutral.
- Authorized a schematic design for reconstructed atrium bathrooms. We have a concept design, ready for further detailing and funding.
- Added two storage sheds on the east side of the building for much needed music department storage, concealed by the memorial garden. We added one shed for the radio club adjacent to the fire road south of the music room.
- Continued to remove at-risk and fallen trees.
- Planted numerous trees to replace the Monterey pines and other trees removed.
- Worked on the skylight leaks and corrected all known leaks. Skylight replacement may be a future needed project.
- Supported the renovation of the newly acquired property in El Cerrito, which is now rented and generating substantial income to support the church.



General info on being a Board liaison (from Bylaws)

Annually the Board will designate a Liaison to each Board Committee and to other committees or program areas of the church, at the Board's discretion.

- Board Liaisons will serve each committee either through attendance at committee meetings or through consistent communication with the Chair of each committee.
- Board Liaisons will suggest agenda items to the Board President when issues of concern to a committee warrant consideration by the Board.
- A high priority for each Liaison is to represent and continually inform the Board of the life of each committee.
- Board Liaisons will educate committees on new Board policies or other work of the Board relevant to the Committee. Each Liaison serves as an educator to the
- ${\it Congregation\ through\ committee\ conversation\ about\ the\ processes\ of\ the\ Board.}$
- Board Liaisons will provide guidance and support to committees during the budget development process.
- Board Liaisons will provide input and guidance to committees when their planned actions or questions might impact Board Policies.

Audit Committee

The Board of Trustees will appoint a three-member Audit Committee including at least one current Board member other than the Treasurer. The committee is responsible for choosing and securing an

auditor, financial reviewer, or other independent financial oversight functions that are required under the Bylaws. The committee receives and reviews the auditor's or the financial reviewer's report and findings, and reports on the audit or financial review to the full Board of Trustees at the meeting of the Board immediately following receipt of the report.

Bylaws Review Task Force

10.4 The Board of Trustees shall appoint a Bylaws Review Task Force at least every three years. The task force shall consist of at least five members with no more than two members of the Board of Trustees. The task force shall review the Bylaws for relevance, appropriateness, and consistency with the Governance Manual.

10.4.1 The task force shall make recommendations for bylaw amendments and solicit recommendations and comments from members of the Congregation.

10.4.2 The task force shall publicize and conduct at least one discussion forum for all members of the congregation. All forums shall be conducted on a Sunday, at least five weeks before any Congregational Meeting.

10.4.3 The task force shall publish and distribute the final proposed amendments to all eligible voting members of the congregation at least three weeks before the Congregational Meeting.

Executive Advisory Team--

The ED shall appoint an Executive Advisory Team to advise the Senior Minister(s) and Executive Director on administrative policy and operations. The Team's function is to serve as a congregational sounding board for executive staff about administrative and operational issues and solutions, and a conduit for congregants to bring administrative and operational issues and solutions to the executive staff. Executive Advisory Team advice shall not be binding on the executive staff.

In addition to the Executive Director and the Minister(s), the members of the Executive Advisory Team at the minimum shall include:

- Program Council liaison
- Board of Trustees President, or their designee from the Board
- The ED or Senior Minister(s) may appoint one or more additional member(s), at their discretion.

Widening the Circle Committee)--

The charge of the Widening the Circle Committee is to be a supportive and advisory visionary body and working group that works in collaboration with UUCB programs to aid UUCB's growth and

commitment to being an Anti-Racist, Anti-Oppressive, Equitable and Inclusive congregation and church organization.

The committee and staff will discern the use of the currently proposed recommendations and develop with the congregation, over time, new ideas and action plans that support the spirit and intent of the UUA's Widening the Circle Of Concern book. The committee's work may include:

- Supporting and coordinating the implementation of Board-approved recommendations from the Widening the Circle of Concern Task Force report (released August 2021).
- Coordinating the discussion of the Widening the Circle of Concern Task Force
 report within the congregation to ensure understanding of and promote engagement with the work.
- Working in concert with the Education for Liberation Development Team (ELDT).
 The ELDT would report to the Widening the Circle Committee.
- Regularly communicating with the congregation to ensure that UUCB programs are following through on the congregation's commitment to Anti-Racism, Anti-Oppression, Equity and Inclusion.
- Giving guidance in accordance with ongoing recommendations from the Commission on Institutional Change of the UUA, which includes providing expertise to and collaborating with staff so that staff and congregational values are congruent. The Widening the Circle Committee includes up to two Board members, the Executive Director and Minister (ex-officio) and seven other church members with commitment to Anti-Racism and Anti-Oppression work, approved by the Board of Trustees. Each member shall be appointed to a term of one to three years, which may be renewed for a total of six years. In the absence of interested members, a current member may exceed the six-year limitation until the Widening the Circle Committee is able to both find and train replacement members who can then function effectively.

Program Council--

UUCB has many committees, teams, and other groups that are active in fulfilling the mission of the church. In seeking greater collaboration amongst groups, greater involvement of groups in the church's governance, and greater fulfillment of the church's mission and Ends, the Board has established a Program Council.

4.2 Program Council Charge

The charge to the Program Council is to support and expand fulfillment of the church's mission and achievement of its Ends by:

- Maximizing communication, support, and collaboration among groups of the church supporting and advising the work of the Minister(s).
- Consulting with the Minister(s) about new or changed initiatives.

- Advising the Executive Director, through the Executive Advisory Team, about programmatic impact on operations, administrative policies, and communications.
- Handling operational responsibilities as designated by the Executive Director or Minister(s) in consultation with the Program Council.
- Encouraging leadership growth.
- Coordinating among groups and collaborating with church staff on community outreach and membership development.
- Ensuring visitors are welcome into church programs open to the community.
- Encouraging membership participation in programs, projects, events, and activities.
- Considering and pursuing program or project initiatives from church groups and congregants, within the mission and budgeted resources of the church.
- Conducting an annual review of programs' and committees' descriptions, mission statements and charges.
- Informing the Board of Trustees about program activities through transmittal of Program Council meeting minutes or other summaries.

4.3 Program Council Leadership

The Council will be coordinated by a Convener, who will have a set term not to exceed three years, and who shall not serve more than two consecutive terms. The Convener will be responsible for convening regular meetings of the Council. Either the Convener or a Program Council Liaison chosen by the Program Council and approved by the Board of Trustees shall serve on the Executive Advisory Team.

4.4 Program Council Composition

The Council will be comprised of representatives of program and operational groups in the church. The specific representation may be modified by the Council in consultation with the Minister(s), and reported to the Board. The current composition includes representatives from:

- 1. Adult Education and Exploration
- 2. Buildings & Grounds
- 3. Chalice Circles
- 4. Communications
- 5. Family Ministry
- 6. Finance/Fundraising
- 7. Membership
- 8. Music and Arts
- 9. Pastoral Care
- 10. Social Justice
- 11. Worship
