TREASURER'S NOTES

The proposed budget for 2014-15:

- Shows a small surplus of revenues over expenses
- Significantly reduces pledge and contribution income from this year's budget, in line with current experience
- Adds a significant amount of rental income
- Has about the same expenses as last year
- Brings all employees to at least UUA minimums*, with those employees at mid-point or above getting no increases
- Includes a significant increase in health care costs (mitigated by moving to a less expensive plan)
- Includes a significant increase for Family Ministry
- Includes smaller increases for Music and Membership

* Subject to income realization, but at least 4%

Significant risks in this budget include:

- Pledge income could fall short by as much as \$60,000
- As of today (May 5) the contract for additional classroom space with our tenant is not finalized


Significant opportunities in this budget include:

- Health care costs could be lower
- Community rentals could be higher

UU Church of Berkeley Proposed Income Budget FY 2014-15



Awards, Canvass and Election

February 9, 2014

MINUTES

Call to Order and Determination of the Presence of a Quorum

President Jean Gleason called the meeting to order at 12:11 p.m., asked for a count and announced that 89 members were present, sufficient for a quorum.

Adoption of the Agenda

President Gleason noted that the motion on land development had been deleted from the agenda at the request of the makers and asked for a motion to approve the agenda with that change. The motion was made by Lois Atkinson, seconded by Austin Henderson and passed.

Reading the Covenant of Right Relations

Paul and Terry Hudson took turns reading the covenant to the congregation.

Approval of the Minutes of Previous Congregational Meetings

President Gleason asked if there were any corrections to the minutes of the May 19, 2013 Congregational Meeting, and Anne Greenwood responded that Merrin Clough's name had been misspelled. The motion to approve the minutes with this correction was made by Larry Nagel, seconded by Patricia Brucker and passed.

Presentation of the Flaming Chalice Awards

President Gleason introduced the winners of these awards, which are given to members who have contributed to the life of the congregation on the recommendation of the past presidents, and the members making the individual presentations:

President's Report

After describing the process by which the church members participated in developing the revised Ends Policies recently adopted by the Board, President Gleason read them to the congregation. The balance of her report was devoted to the transition facing the congregation now that our ministers have announced their retirement and the process of finding an interim minister, which is the first step. She counseled patience, not panic.

Treasurer's Report

Linda Laskowski introduced the members of the Financial Council, newly formed to improve the transparency of the Church's finances, and then invited the congregation to step into discomfort as she talked about the future of the Church. She listed the assets, debt free land and buildings, the endowment, capital campaign funds already collected, and human capital including both staff and volunteers, saying we're a long way from financial catastrophe. She then presented slides to illustrate where the trends in declining membership and income would lead if not reversed. She concluded by pointing to the recent increase in new visitors as a leading indicator of success and urged continued discussion of how to generate income from the vacant land.

Ordination of Marcus Liefert

A motion to partner with the Oakland church to ordain Marcus Liefert was made by Paul Hudson, seconded by Warren Zittel and passed, with applause.

Contra Costa Interfaith Coordinating Organization Affiliation

Craig Scott asked members of the congregation who had been working with CCISCO to stand and then described the nature of the organization. We would be joining with other congregations and community groups and the dues would be \$1000 per year (half the first year's dues to be paid by the UUA). Craig made the motion to affiliate with CCISCO, Ellen Fisher seconded it, and it passed.

Coordinating Team Reports

Beth Pollard reported on the Capital Campaign that has \$811,000 pledged to improve buildings and grounds, and the CT's work of stewardship of assets. She noted that the membership ministry is being supported by Alisa Gould-Sugden. She thanked Cynthia Asprodites for five years of service on the CT, Kay Fairwell for stepping in when Margaret Goodmundsen died, and Jane Middleton who will be joining when her term on the Board of Trustees ends.

Bob Moore reported for the Stewardship Team, whose theme is "gearing up for the greater good," and quoted Jane Lundin from the kickoff event, that giving "makes me feel good," urging all to pledge.

Tom Tripp reviewed the process by which the capital improvements had been determined, from the reserve analysis on, including the formation of the projects management team and their concern for safety, quality, cost and schedule. He then made the motion from the agenda, that we approve a Capital Expenditure Plan to accomplish the project scopes in the Victory Goal and the Challenge Goal of the Taking Care of Our House Capital Campaign as funding allows, and projects in the Miracle Goal only if additional funds become available. The motion was seconded by Syndey Williams and members of the congregation discussed it. Bob Moore called the question, and when that motion passed with more than two thirds in favor, the main motion passed with only two opposed.

Tom then made the second motion, that we authorize a loan from Endowment Funds for the Capital Expenditure Plan. It will be no more than 90% of the total pledges minus what has already been collected in Capital Campaign funds and will be repaid. Ira Nelken seconded the motion, and it passed 86 to 4.

Linda Laskowski reviewed the Land Development group's process and introduced the consultants, Equity Community Builders. Suzanne Brown of ECB spoke about the process and potential of both residential development and school expansion.

Recognition of Outgoing Board Members

President Gleason thanked Stephanie Ann Blythe, Lynnette Delgado and Jane Middleton for their service, presented flowers to Stephanie Ann and Jane (Lynnette was not present) and the congregation applauded.

Results of the Election of New Board Members

Jane Middleton, acting as Vice-President, announced that Jean Gleason and Virginia Silver-Rimbach were re-elected (for three-year terms) and that the new Board Members are Lee Lawrence (three-year term) and Maryann Simpson, Mitch Sukalski and Miquette Thompson (all for one-year terms).

Installation of the New Board of Trustees and Blessing

Barbara and Bill Hamilton Holway then installed the new Board members, asking the congregation to support and encourage them and receiving a strong "we do" in reply. They concluded by blessing those that do the work and stay to the end, lead with integrity and joy, and with calm leadership in a time of transition.

Adjournment

President Gleason declared the meeting adjourned at 2:23 PM.

Celebration and Planning

May 19, 2013

MINUTES

Call to Order and Determination of the Presence of a Quorum

President Jean Gleason called the meeting to order at 12:06 p.m., asked for a count and announced that 74 members were present, sufficient for a quorum.

Adoption of the Agenda

President Gleason asked if there were any amendments to the agenda and Susan Lankford asked to have the Land Use Task Force Report added after the motion on Capital Campaign priorities. There was then unanimous consent to the adoption of the agenda as amended.

Reading the Covenant of Right Relations

The congregation stood while John Bailey and Mary Pugh read the covenant.

Approval of the Minutes of Previous Congregational Meetings

President Gleason asked if there were any corrections to the minutes of the February 10, 2013 Congregational Meeting, and hearing none asked for a motion to approve them. The motion was made by Austin Henderson and seconded by Warren Zittel and was passed.

Presentation of the Schweitzer Medals

Anne Greenwood and John Tucker presented medals to Lynne and John Cahoon, listing their long and varied service to the church, and the congregation stood to applaud them.

Approval of Sue Magidson's Affiliation with UUCB as a Community Minister

The motion was made by David Thomas and seconded by Maryann Simpson and passed unanimously -- Sue Magidson said she could hear the "ayes" through two closed doors.

State of the Congregation

Promising to be briefer than President Obama's State of the Union, President Gleason mentioned a number of good things that had happened during the year, thanking David Lingenfelter for his work on revising the governance manual, recognizing the work of the outgoing ministers, Marcus Liefert, Sherri Prud'homme, and Amy Moses-Lagos, and our members' involvement in the denomination, including Susan Lankford, Bill Hamilton-Holway and Linda Laskowski. She also celebrated our work for social justice, from the Read Aloud program to all the members in their yellow shirts at immigration demonstrations, and finished by inviting everyone to contribute to envisioning the church's future, starting with the café conversation on June 29th.

Coordinating Team Reports

Beth Pollard, standing in for Cynthia Asprodites who was absent on family business, reported on the Coordinating Team's work, noting in particular the successful search for a director of religious education, the Chinese immersion school that is moving this month into the space vacated by the German school, the River of Life mosaic mural that was funded by gifts in memory of Joan Swift, and Anne Greenwood's six years of outstanding service as Treasurer.

Katherine Jay, co-chair with Paul Hudson of the search committee, reported that Merrin Clough would join the church as RE director in August, and described her skills with enthusiasm.

Patrick Cullinane reported on the work of the Capital Campaign Leadership Team that he co-chairs with Jan Setchko, quoting T. S. Elliot about beginnings, the campaign being the beginning

of continued blessing for the lives of members and welcome to religious seekers for years to come, and asking for members to share their ideas now and their money in November.

Tom Tripp reported on the process of prioritizing the repairs and improvements to be funded by the capital campaign. In response to a question from Ann Harlow he estimated the costs of this process as between \$5000 and \$10,000.

Motion to Approve Funds for the Initial Phases of the Capital Campaign

The following motion was submitted by the Coordinating Team for inclusion in the agenda:

That we approve the expenditure of capital campaign funds to move forward on the Capital Campaign "Taking Care of Our House" that seeks to improve our atrium, patio and other spaces, strengthen the condition of our physical plant such as our roof, flooring, and heating, and analyze the potential for other property improvements to sustain our facilities.

Beth Pollard withdrew this motion and offered the following motion as a substitute:

Whereas in a congregational meeting in December 2012 the following motion was passed: *"The members of the Unitarian Universalist Church of Berkeley affirm to have a capital campaign in the Fall of 2013: the proceeds of this campaign not to be expended until a plan for the expenditures of the campaign proceeds is approved by the members in a congregational meeting."*; and

Whereas UUCB shall be in receipt of some advance capital campaign donations prior to the official launch of the campaign; and

Whereas task forces organized by the Coordinating Team continue to analyze and prioritize the needs of our physical plant; and

Whereas expenditures on professional and consultant fees are necessary to refine the scope of some capital projects under consideration for the capital campaign;

Therefore, we move that:

1. Administrative costs of the campaign may be expended immediately;
 2. Normal and reasonable professional costs directly pertaining to the scope listed below, shall be part of the capital campaign plan;
 3. Capital campaign funds may be expended immediately towards this scope; and
- This scope may be expanded or modified by the congregation in the course of the capital campaign, in accord with the December 2012 motion.

Preliminary scope for which professional costs are authorized:

- Atrium: heating, skylights, bathrooms, new doors to patio and entrance, Social Hall and Sanctuary
- Landscaping: new plantings, removal of diseased Monterey pines
- Painting
- Parking lot and pavement: repair and improve
- Patio improvements: landscaping and beautification, lighting, repaving
- Roof
- Sanctuary: repairs to floor
- Utility upgrades: heating, electrical, plumbing
- Walkways and stairs: repair/replace/install, for access and safety

The motion was seconded by Kay Fairwell and discussed by the congregation at length. In response to a question about administrative costs Margaret Gudmundsson explained that these

would include printing and postage, the costs of keeping the members informed. A cap on these expenses was suggested but greater trust in the integrity of committee members was favored by most speakers. After a call for the question, which passed, the motion was passed unanimously.

Land Use Task Force Report

Susan Lankford narrated a slide show demonstrating the range of ideas the task force has been investigating in search of a plan that would yield an income stream for the church. Because it was already getting late and the budget was still to be considered President Gleason asked that questions be directed to Susan and the other Task Force members outside the meeting.

Beth Pollard, on behalf of the Coordinating Team, acknowledged the important work the Land Use Task Force has been doing in exploring future possibilities for the church's property and the congregation's consideration of them, and recognized the need for funds for professional services to fully understand the pros and cons of the plans they are developing.

Finance Reports

Anne Greenwood summarized last year's finances, giving thanks for pledges in excess of the budget, hardworking fundraisers who put on events like the Fiesta and Driving Miss Daisy, and those who helped secure the new school building tenant. And she announced that Linda Lasowski would take her place as Treasurer starting in June.

Austin Henderson gave the Stewardship Team report, mentioning the varied events they had planned and asking everyone who had not yet pledged to do so quickly to facilitate the planning and budgeting process.

Anne Greenwood then presented the budget for 2013-2014. Approval was moved by Ralph Nelson, seconded by Dave Rockhold, and after Lynne Cahoon expressed what everyone was thinking, that we should just give Anne Greenwood a hand, vote and go home, it was passed unanimously, with thanks to Anne for her six years of dedicated service.

Endorsement of the Nominating Committee Members

Jean Gleason moved and Warren Zittel seconded a motion to endorse the Board's recommendations for the Nominating Committee: Lynne Cahoon, Selene Fabiano and Abbot Foote for two-year terms with Ellen Fisher as Alternate. Continuing members are Kathy Guarneri, Monica Riley and David Rockhold with Maryann Simpson, the alternate, serving due to a resignation. The motion was passed.

Blessing and Adjournment

President Gleason offered a blessing adapted from John C. Morgan: Let us bless, and keep and support one another. Let kindness rule in our hearts and compassion in our lives, until we come again to this wonderful community. And with thanks to all, President Gleason declared the meeting adjourned at 12:58 p.m..

ALBERT SCHWEITZER MEDAL

At this year's May Congregational Meeting, the Awards Committee and the Board of Trustees awarded the Albert Schweitzer Medal to **Abbot Foote** and **Craig Scott**.

Schweitzer Medals are awarded to recipients who have been supporters of Unitarian Universalist churches for at least fifteen years and of our church for five years; who have participated in a number of church functions "above and beyond the normal call of duty;" who have been church leaders; and who have participated in outreach activities.

Abbot Foote by Linda Laskowski

Everyone needs a visionary, and Abbot Foote is mine.

A multi-generation UU, oops, I guess that would have been a "U", Abbot is no stranger to long term thinking. We make a good pair: while Abbot is working towards what the world needs in 2114, I am concerned about getting the church through next Tuesday.

Abbot was working on sustainability and solar power long before it was fashionable. As I described when I presented Abbot his flaming chalice award from this church in 2007, his stealth replacements of energy efficient bulbs and other devices, the first one in 1987, has probably saved this congregation hundreds if not thousands of dollars over the past few decades – most of that unrecognized. His suggestions about putting in solar panels decades ago were drowned out by concerns that we would never get our investment back, we should wait until the technology got better, we had too much fog and too many trees, and where would we get the money anyway?

From 2003 to 2008, Abbot and I were part of the team that eventually installed 336 panels above us, providing what is essentially all our electricity at zero cost (about \$20,000/year) – paid for by a loan from our endowment that was paid off last fall. This was part of Abbot's vision, his dream – not yet come to completion. That dream is solar panels on the roof of all UU churches.

So when I was asked to head a Land Use Task Force to address how we might insure the sustainability of this building, I went to Abbot. When I announced his addition to the team at a congregational meeting over a year ago, you all cheered. The discussions on the Task Force can be difficult, but I cannot imagine anyone whose voice is more important. For such a gentle man Abbot asks really hard questions: where is the building reserve in this budget? what are we doing to build the endowment? should we invest in a building that may not be sustainable? can we stay here? even if we successfully develop part of our land, where does the rest of the needed building investment come from?

These questions come from Abbot's sense of history and his dream of what is possible, even when faced with daily reality. This is Abbot's greatness, and why this award is so appropriate. To quote Tecumseh, a Shawnee leader at the turn of the 19th century, "when the dreams end, there is no more greatness".

Craig Scott by Natalie DaSilva

It is indeed a great privilege to present this award to Rev. Craig Scott today. Craig has been a UU and a member of this congregation since 1998. He graduated from the Pacific School of Religion in 2004, and was ordained to the UU ministry here at UUCB in 2005. Craig has stood on the side of love, compassion, and justice long before the Standing on the Side of Love campaign unfurled its gold banners, and has often stepped forward in roles of leadership. In his earlier career as an attorney, he represented farm workers in the Central Valley, and other low-income, marginalized people over many years.

Here at UUCB, Craig has been part of a very special Evensong group since 1998, and has led several other Evensong groups. He has taught RE classes, and was part of the Caring Circle as a seminary student. He created and led a curriculum based on Karen Armstrong's "12 Steps to a Compassionate Life", and has led a Buddhist meditation group. He has played an active role in many immigration-related events as a member of our Immigration Justice Working Group.

Most recently, Craig facilitated the formation of a team of UUCB members to shepherd this congregation into formal membership with CCISCO, Contra Costa Interfaith Supporting Community Organizing, to help us all live our UU values more fully. Through Craig's tireless leadership with CCISCO, UUCB has participated in the Campaign for Citizenship, Richmond Ceasefire/Lifelines to Healing, and the Richmond Bay Campus, to name just a few.

Craig was the first minister to serve the UU Fellowship in Sonora, California, where he served for seven years. He will be named "Minister Emeritus" when he retires from that ministry in June.

If there is a public witness, or a public meeting, where the needs of the marginalized and disenfranchised are raised, and the call is for more justice and compassion, look for Craig. He will be there – and with a message that is grounded in faith, joy, hope, good humor, and humility. When I need inspiration and encouragement for continuing the work of bringing more justice into the world, I turn to Craig. It is an honor and a joy to work side by side with him, as many of you already know.

So, Craig, thank you for all you have given of yourself so far, and (borrowing one of your favorite sayings), may you continue to comfort the afflicted and afflict the comfortable. Namaste.

Christina Creveling by Lonnie Moseley

- Volunteer on the Welcome Table and continues to welcome and greet each month
- Asked to be on Sara Roberts' Membership Steering Committee where Christina organized a team to do 4 or 5 New Member Breakfasts
- Christina has Co-led a Chalice Circle
- She listened three times in the Listening Campaign
- Mentored in the “Coming of Age Program in 2007”
- And then Christina volunteered to run for the Board! When I came onto the Board benefitted tremendously from her astute and sane observations.

While on the Board, Christina was on the Ends Rewrite Committee of 2009; at least three task forces, one or two working groups, and spoke to the Thursday night service 3 times.

And now she sings with the Early Birds, meets monthly with the Aesthetics Committee and still greets with me on the door. Wow.

But what I am MOST grateful to Christina for and I know she's proud of it, too, is how she joined with Board member, Bob Adams, to propose a Board Chalice Circle. This Chalice Circle helped the Board to change the tenor of its culture and to become a living embodiment of the UUCB Covenant.

Christina, when I told Cordell that you were receiving the Chalice Award, he immediately said, “You know, Christina doesn't like a lot of “thank you” and it's because she thinks giving and service is what you just do.”

And yes, my dear friend, Giving and Service IS what you just do. And I'm so grateful that you are in the world.

Larry High by Jan McClain

Compassionate. Caring. These are the words I have heard often as I've talked with others about Larry High. As Larry has participated deeply in this congregation for almost a decade, he has left his very personal mark on those around him. He has this marvelous sense of being able to act quietly, yet influentially, with a voice of reconciliation that comes from his intense love of people.

As Kai and I began attending this church, I remember seeing Larry every Sunday a few rows ahead--faithful, attentive, kind to others. He had such a sense of presence. We joined at approximately the same time and since then he has found many places to serve here. He has been a Chalice Circle participant, a devotee of Personal Theology and the classes on Non-Violent Communication, and an usher when needed. He was a table chairman for the Capital Campaign. He participates in the monthly prayer vigils outside the Contra Costa Detention Center. When he talks about these vigils, his deep love of humanity comes to the fore--standing outside, making noise with the others so that the immigrants inside can hear and be uplifted.

Those who served with him report that he was exceptional--the voice of wisdom and balance, truly speaking from his heart. He was a synthesizer--deepening the discussion--encompassing the interests of all the ages and groups here--caring about the welfare of others.

As part of his job on the committee, he scheduled those who would speak in the Sharing the Journey portion of the service. He was meticulous and kind with this--sometimes it took some serious convincing, but Larry's patience and attention brought many of us up here to bring forth our truth. To feel his support and see his joy as we stood up here was love in action. He truly is a Gentleman of the UUCB.

Lisa Maynard by Kay Fairwell

Lisa Maynard is one of our unsung heroes. She quietly goes about doing what needs to be done—without a lot of fanfare. Her list of contributions is long, and our allotted time isn't.

So, some highlights.

Lisa joined a Chalice Circle in 2007, and since 2009 has been a facilitator. She is currently co-facilitating the Chalice Circle program. Through Chalice Circles, she became involved in various church events such as the Obama election-night celebration and the Doctors of Durability luncheon. Deborah and Daniel were married at UUCB in 1981--almost 33 years ago--and Deborah served on the Religious Education Committee and as Children's Music director from 1993—1996, raising enough money to buy instruments the children are still using today. ("We served a lot of lunches," she said.)

After joining the choir in 2004, Deborah joined the Music Committee in 2008. Since last year she has worked with the newly-formed Luminosity Events Subcommittee to attract new people to the church through concerts—not only Bryan Baker and Friends, which I hope you heard last night, & Love Songs & Chocolate coming in March but also outside groups like the Yale SOBs. As you undoubtedly recall, SOB stands for Society of Orpheus and Bacchus, and it not only created revenue for the church but also attracted many people I'd never seen before.

The committee meets at least quarterly, and more often if needed.

We have reviewed and revised the Gift Acceptance Policy and the Endowment Policy. No substantive changes were made to the Gift Acceptance Policy. The endowment policy changed the formula for the recommended annual payout to the operating fund to reflect a more conservative payout as follows:

"The intent of the Endowment Fund is to provide a permanent source of income to support the UUCB's work. The level of annual expenditure from the Endowment Fund (the "Annual Amount") will be recommended by the Endowment Committee in consultation with the Coordinating Team and adopted by the Board. The level of base payout will be 4%, with an additional payout of 0 to 1.5% based on the following:

- * the endowment's rate of return for the past 12 quarters (as reported by the UUA)
- * the potential effects of inflation or deflation
- * the potential use of the funds for one time versus ongoing operations, for example, start-up costs for a new program or staff member, or hiring of consultants for a specified project."

This policy was adopted by the Board at its February 2014 meeting.

We have revised the Maybeck Legacy brochure and offered a workshop on wills and estate planning led by Sara Diamond, a Berkeley Estate Lawyer.

Family Ministry Committee

Mission Statement:

The Family Ministry Committee is the support committee for the Director of Family Ministry, the religious education program for children and youth, and our community of families. In collaboration with the Director, the Committee helps to develop plans and policies to foster a rich and growing program that will prepare young Unitarian Universalists for a lifetime of spiritual and ethical exploration and growth. The Committee also works to build community among families and with the wider church by supporting our Director in connecting and meaningfully engaging people in the program. The Committee is invested in cultivating a sense of shared ministry within the program and with the wider church that fosters a multi-generational community of faith at the Unitarian Universalist Church of Berkeley.

The group's activities and accomplishments over the last year include starting with our new Director of Family Ministry, Merrin Clough, running a successful RE program for pre-school to 5th grade, providing teacher support, teacher/facilitator trainings, YRUU group, MUGGS group, monthly Family tUUGther nights, Family Thursday night suppers, a monthly meeting for parents of children with special needs, twice a month parent discussion circle, child care for events and services, tween/teen game nights, Our Whole Lives, Halloween haunted house, Family/ Congregation potlucks, Easter Sunday breakfast, egg hunt, end of year BBQ/field day, summer religious education program, Bring your weight in Food, Youth and Children's Choir, and children reading the call to worship.

Membership Ministry Committee

Mission Statement

The Membership Ministry Committee works to make the Unitarian Universalist Church of Berkeley a welcoming and inclusive spiritual community. We reach beyond our church walls to strengthen UUCB's visible presence in the wider community. We reach within this church community to guide newcomers along the path to membership, and nurture newcomers and members alike towards greater involvement and leadership in the congregation.

Leadership Transitions

The Membership Ministry Committee (MMC) – newly renamed from the Membership Committee to reflect our active role in the ministry of our congregation, in 2013 had new leadership in place, after Sara Roberts stepped down from six years of service, and after about a year without volunteer leadership. Lonnie Moseley and Paul Hudson will serve as co-chairs of the MMC for three year terms. Alisa Gould Sugden, our Membership Coordinator on staff, continues to lead and support ongoing committee functions, activities, events, and initiatives.

Alisa coordinates ongoing functions of the committee, such as staffing of the Welcome Table and

Greetings, organizing new member welcome services, printing nametags, tracking newcomers in the database, among many other duties. Lonnie and Paul are focusing, respectively, on initiatives for In-Reach and Out-Reach, while also supporting Alisa in committee activities. Alisa, Lonnie and Paul together serve as leaders of the MMC.

Lonnie's In-Reach activities are focused on making UUCB an inclusive and welcoming community to newcomers, and finding ways of engaging and nurturing all people in our church community towards membership, greater involvement, and leadership, and deep spiritual and personal connection.

Paul's Out-Reach initiatives seek to make UUCB better known beyond our church walls. The Outreach Action Team has been organized to take on projects from small to large, from one-time to ongoing, to make our presence widely known. This include the use of social media (Twitter and Facebook), planning new outreach events in addition to the Solano Stroll (such as the MLK Day Parade in El Cerrito, in which we marched this year), organizing an ongoing "Invite Your Friends" information campaign, and making sure that everything we do at UUCB – from our Good Neighbor offerings to our partnership with CCISO to our music and performance events – are made externally – and internally – visible. New members and projects leaders are needed for the Outreach Action Team – please speak with Paul.

Lonnie's In-Reach initiatives include reviving a former New Member "Buddy" system where a current member of the congregation partners with a new member to be a support, answer questions, and help guide the new member's spiritual interests (connecting the new person with people who have participated in Chalice Circles, Choir, etc.). Another initiative is to have a buddy or Membership member accompany new members to at least one Thursday night dinner without charge so that new members become familiar with this wonderful connection. Lonnie continues to manage the members who welcome on the front doors of UUCB and plans to expand the list of Greeters so to engage more congregants.

The MMC has set a five year membership goal of 500. This will be a challenge. Our current membership is under 430, after several years of steady decline. We will need to do better at retaining members through our In-Reach initiatives, and do much better in attracting newcomers through our Out-Reach activities. If we all work together to make UUCB as welcoming, inviting, visible, engaging, justice seeking, and alive as we can, we can meet this challenge, while making UUCB that much more of wonderful place for ourselves. We need YOU!

Music Committee

The past year has been quite a busy one for the Music Committee. We started with an ambitious project of re-leathering the organ. We birthed a new concert series, and we continued our support of our traditional music programs.

Our organ, which is an integral part of our sanctuary, has been aging. The sanctuary and the organ were made for each other. As the sanctuary has deteriorated so has the organ. As an investment, our Aeolian-Skinner organ would cost over a million dollars to replace. It seemed only reasonable to replace the parts that had worn out over 50 years.

Some of the key components of our organ are made of supple leather. They had grown hard and ceased to function properly. There was also some water damage due to a leak in the roof, which further hardened the leather. The re-leathering entailed replacing over six thousand pieces of thin leather: two leather pieces for each of the organ's 2,957 pipes, plus bellows leather and other

leathers. The organ had to be taken apart, and many small pieces of leather, and other parts had to be fabricated, replaced, and reassembled. There is no organ parts store, so these are fabricated by hand.

Jo Maxim, Patricia Ellis, Marion Anderson, and many others took on the daunting task of raising over a hundred and fifty thousand dollars for the project.

Marion Anderson took on a key role as the liaison between the church and Schoerster & Company, with much help from Ron Swedlund, who was our organist at the time. They started the work in July, and finished in September. We give many thanks to Jo Maxon, Karl Rupenthal, Patricia and Wally Ellis, and many others for their extremely generous donations.

Luminosity Events is our new concert series drawing performers and visitors to its spectacular venue with a mix of cultural events as vibrant and eclectic as the people of our Bay Area. Guided by the UUCB mission and managed by the Luminosity Committee, *Luminosity* supports the growth and diversity of UUCB and its connections to the wider community.

We provide opportunities for performers to engage with church life and programs beyond the concert series through workshops and appearances in worship services. We are open to partnership with other non-profit organizations.

We have incorporated our existing concerts as well as new ones with outside groups. It has been a huge success. To raise money for the UUCB general fund and to reach out beyond the congregation the choir performed in a number of events. The *Messiah Sing-Along* in December was the best attended yet, and our most successful community outreach. Earlier that month, the choir sang for the Shadi Christmas Display on Moeser, which was another cheerful and successful outreach event. Love Songs & Chocolate was yet another fundraiser for the church, and we included two new elements this time. We joined in honoring the Doctors of Durability, and also shared the income generated with an outside group: the Read Aloud Program.

The Joint UU Choirs concert in April is a tradition that UUCB has spearheaded in recent years. It not only brings funds in, it also builds connections with congregations across the Bay Area. By collaborating with the Kensington Symphony Orchestra, we encourage further outreach to a diverse audience of potentially interested community members. In addition we brought in outside groups such as Yale University's a cappella group The Society of Orpheus and Bacchus. Our most recent concert was the debut of Serenade, Strings, and the Mad Diva, which was made up of the Serenade Chamber Choir, Ashton String Quartet and our own Marcelle Dronkers as the Mad Diva.

We are blessed at UUCB to have a wide range of extremely talented musicians, both as paid staff, as well as lay musicians, with positions such as Section Leaders, Youth and Children's Choir director, and organist to name a few. Luminescence, led by Dr. Bryan Baker, is a dedicated choir who are ever-present at Sunday services.

The choir prepared, rehearsed and sang in-service a variety of music. Pieces were chosen to link with the theme of the service. These pieces inspired, delighted, soothed, or gave focus to the congregation as fit the day.

The choir had a number of special events during the year, and special rehearsals in preparation for these. Two Music Sundays offer extra time for music to further the message in service. Christmas Eve and Easter always call for an abundance of music of exceptional expressive character.

As a community, the choir comes together in support of members with health challenges, their own or those of a loved one. We have welcomed new singers, supported continuing singers, and built bonds while preparing music for services and events. Many have volunteered to perform at memorials and other community events outside the regular choir schedule.

Daniel Schmidt leads the Gamelan group, in songs for our Sunday services, as well as other performances around the community. Daniel has a report submitted separately.

We have been graced with the tunes of Muse Crossing, and the Early Birds.

The Youth and Children's Choir currently boasts about 16 singers, ranging in age from 5-14. The Choir helps lead the 11 a.m. worship service once or twice a month and provides music for a Christmas Eve service and an Easter Service, as well as other events throughout the year. The YCC is a remarkably friendly and fun-loving group of musicians, who are very welcoming of newcomers. Many singers say that being in the YCC is one of their favorite things about UUCB. They appreciate being able to lead worship and offer pieces they have arranged just for you. Thank you for making space at UUCB for to connect and share the joy of music!

For anyone in the congregation, wanting to learn how to sing, Michèle Voillequé offers a class for you- "Everyone can sing, we just need to know how."

We are very pleased that the choice of Katya Kolesnikova as our new organist has proved such a good match for UUCB. She is trained as a professional musician at Conservatory in Russia and Church Music Institute in Germany. She has over 25 years of experience as a professional musician, and over 14 years as a church organist. She embraces a wide variety of musical styles while setting her preferences on traditional 'classical music' styles. She is flexible with experimental and diverse music.

In the future we plan to fill out our concert series, and expand its reach to more of the surrounding community. We are planning more education opportunities for members of the congregation, and our existing programs, as well as reaching out to the outside community.

We will continue recruitment for music programs as a means to giving members a meaningful connection and interaction as a spiritual interaction, as well as enhancing community worship.

Music Program at UUCB - Mission Statement

The Music Program at UUCB offers high-quality music designed to touch people intellectually, emotionally and spiritually. This is done through a variety of musical media including excellent keyboard instruments, the inspiring Gamelan Ensemble, our extremely talented music staff, Youth and Children's Choir, the adult choir Luminescence and guest musicians.

Goals:

Provide beautiful and appropriate music within worship services to deepen and enhance the spiritual experience.

Educate members of the congregation about music as well as provide enjoyment by presenting pieces from a variety of periods and traditions during Sunday Worship Services.

Involve the congregation and surrounding community in annual programs such as the Messiah Sing-Along and Christmas Eve services which provide inspiring group singing experiences.

Present musical programs throughout the year for the congregation and surrounding community

to raise funds for the UUCB General Fund.

Encourage members to embrace music through participation.

Transylvanian Partner Church Committee

Mission Statement:

We endeavor to join with our partners in faith in Homoródújfalu to exchange the stories of our lives, to deepen our faith, to share our learnings and resources in order to support each other's dreams.

Goals:

- Educate our own congregation about our partner church and deepen our mutual understanding of each other's churches including historical roots, culture and current issues.
- Provide financial support for mutually agree upon projects and continue to support the Village Education Fund. [We currently send \$400/year per student in two installments in May and December. The students are selected by the Homoródújfalu Education committee]
- Support and encourage our partner church congregation as they strive to integrate into the European economy.

The Transylvanian Partner Church Committee seeks to fulfill UUCB's End Statements in several ways. Two, in particular stand out:

- Children, youth, and adults experience and explore the wisdom that all religions have to offer and can express UU principles and values.
- Congregants can fulfill the UU values of social and environmental justice, and community organizations experience UUCB as an active and dynamic partner in this work.

Transylvanian Unitarians live and worship a tradition largely unchanged since the 16th century. American Unitarian Universalists learn to appreciate the differences and similarities of these divergent theologies that rose from common roots long ago. In the past year we have learned of efforts to expand mining in the traditional Unitarian lands of Transylvania. While our partner church village is not threatened, we are striving to help our Romanian friends deal with this economic justice issue.

Activities:

We served lunch at the snack table on several Sundays in the past year to raise funds for the Village Education Fund. A raffle of embroidered linens from Homoródújfalú was also held. UUCB is the host congregation for this year's Balazs Scholar at Starr King School for the Ministry along with his family. He is the Rev. Károly Vass who serves the congregation in Sepsiszentgyörgy, Transylvania. UUCB member and Starr King seminarian Jo Green traveled to Transylvania and Homoródújfalú as the 2013 Starr King Immersion Scholar. A potluck lunch on September 29 was held where Jo made presentation about her experience in Transylvania. UUCB Board President Jean Gleason and Larry Nagle also traveled to Romania in 2013 and visited our partner church, enjoying the hospitality of the Rev. Ilkei Arpad and his wife Judit. Our RE classes have done various art projects which are sent to the children of Homoródújfalú, including holiday greetings for Saint Nicholas Day which is celebrated in early December. Regrettably, the latest news from the village was about a fire in March, 2014, which destroyed three barns along with equipment and livestock. We are currently seeking donations in our congregation to aid the victims in Homoródújfalú.

Contra Costa Interfaith Supporting Community Organization (CCISCO) Team

On February 9, 2014, the congregation voted unanimously to enter into a formal affiliation between UUCB and Contra Costa Interfaith Supporting Community Organization (CCISCO). We are one of about 20 Contra Costa County congregations that are CCISCO affiliates.

During the past year, our core leadership team has participated in community organizing training, in-house organizing meetings, and various community activities through CCISCO (described below).

Our CCISCO affiliation provides opportunities for congregants to “fulfill the UU values of social and environmental justice, and community organizations experience UUCB as an active and dynamic partner in this work.” (From UUCB End Statements).

Our CCISCO team is inclusive. We invite any member interested in working with us to build community within UUCB and our wider area to join together with us.

Mission Statement:

The CCISCO Team's core mission is to build and sustain “beloved community” within our walls and within our local areas. Through building community, we seek to promote equity and justice on a range of issues consistent with our Unitarian Universalist values.

We partner with local congregations and community organizations to counter oppression, injustice, and inequality.

Activities over the past year:

- Organized a core leadership team to train in community organizing and to work with CCISCO to accomplish a formal affiliation;

- Participated in the Richmond Lifelines to Healing (Ceasefire) program. Many of our members gather at local churches to walk through local neighborhoods, promoting a message of “alive and free;”

Participated in meetings of clergy from churches in the Richmond area to promote connection among local congregations and coordinate justice work;
Engaged in community advocacy concerning the UC/LBNL Richmond Bay campus to be located in Richmond. Our advocacy is aimed at ensuring that the project includes binding commitments concerning education, job opportunities, local business opportunities, workforce training, and housing relief;

Participated in immigration-related activities including:

- local advocacy to convince the Contra Costa County Sheriff to limit cooperation with ICE under the SCOMM program;
- Working for passage in California of the TRUST Act which assists people in danger of deportation;
- Assisting young undocumented “dreamers” with their applications for temporary non-deportable status under the DACA program;
- Advocacy for federal immigration reform, including participation in public actions;
- Co-hosting with CCISCO an immigration vigil at West County Detention Facility.

UUCMCA continues to work through partnerships with other organizations in the areas of economic justice, environmental justice, LBGTQ equality, healthcare, and has recently adopted immigrant justice as a 6th area of emphasis.

Our UUCB immigrant group has been participating in events with UJUMCA under the leadership of Natalie DaSilva and Jane Middleton. Lee Lawrence and Sarah Armstrong participated in a Economic Justice workshop and training at the Mt. Diablo Unitarian Universalist Church. This committee continues to bring the opportunity to participate in a statewide network of Unitarian Universalists on issues critical to the future of the state of California. In the light of the current drought, our work on water justice and ensuring the right to clean drinking water for all citizens appears prescient. Our community minister, Rev. Sonya Sukalski has been participating in leadership training for young adults, and is currently walking the Pacific Coast Trail for water justice. May is Membership month for the UJUMCA. Unitarian Universalist Service Committee

The Unitarian Universalist Service Committee (UUSC) is a human rights organization powered by grassroots collaboration. In 15 countries throughout the world, UUSC fosters social justice and works toward a world free from oppression. UUSC's innovative approaches and measurable impact are grounded in the moral belief that all people have inherent power, dignity, and rights. UUSC advances human rights and social justice around the world, partnering with those who confront unjust power structures and mobilizing to challenge oppressive policies. UUSC envisions a world free from oppression and injustice, where all can realize their full human rights. UUSC is a nonsectarian organization whose work around the world is guided by the values of Unitarian Universalism and the Universal Declaration of Human Rights.

Our committee at UUCB works to support UUSC and communicate its activities and goals to our congregation. During the holidays we participate in Guest at the Table, a program providing small boxes for remembering those in need around the world at our holiday tables. Natalie DaSilva and her son, Nathan DaSilva organize and distribute the boxes within our congregation. Our church also donates \$2 per member to support UUSC in its activities around the world. Every day, UUSC is taking action to advance a full array of human rights — promoting economic justice, bolstering environmental justice, and protecting civil liberties. UUSC also works to deliver aid with dignity and advance the rights of people left behind during humanitarian crises, which include forgotten conflicts and natural disasters. Specifically, UUSC engages people in owning their power as values-driven consumers, acting to protect workers' rights, and joining a movement for economic justice. In the wake of the 2010 earthquake, UUSC has made a long-term commitment to creating a recovery that advances justice for Haitians.

UUSC is on the cutting edge of ensuring that all people — no matter their skin color or bank account — have access to safe, affordable water. We work through partnerships with indigenous organizations that share our values; we attempt to innovate creative solutions that could be replicated throughout the world, and we try to mobilize active UUs to work for social justice. Building Project Management Team

The Coordinating Team (CT) officially appointed John Cahoon, Larry Nagel, and Tom Tripp as the UUCB Building Project Management Team in January, 2014. The mission of this team is to coordinate and oversee the building construction projects which are funded by the proceeds of the 2013 Capital Campaign.

Our responsibilities include the following items:

- determining the scope of each project
- writing Request for Bids for each project
- putting the projects out for bid
- awarding the bids
- obtaining the necessary permits and approvals from Contra Costa County
- scheduling the work on the various projects
- supervising the projects to ensure that each project is performed to the level of quality that everyone at UUCB expects

The Project Management Team will provide monthly reports to the Coordinating Team on the status of the projects, as well as greatly shortened status reports in the Beacon.

The Project Management Team has the overarching goal of enhancing our precious building to remove safety hazards, renovate, replace, or repair many major systems which are now more than fifty years old, and ensure that the building better meets the needs of all congregants. In this sense, the work of the Project Management Team supports all of the Ends recently adopted by the UUCB Board of Trustees.

Developing Indigenous Resources (DIR) Friends

DIR is Developing Indigenous Resources, an NGO founded by UUCB member Frederick Shaw who is working primarily in two slums in Chandigarh, India.

Mission Statement

The purpose of Friends of DIR is to:

- Formalize the relationship between UUCB and DIR.
- Instigate and support efforts to raise funds for DIR.
- Educate the UUCB membership about the efforts of DIR to promote social justice in the wider world.

Activities and accomplishments over the last year:

DIR:

- The Infant Mortality Rate in the slums in which DIR works is now 20% of what it was when the project began 8 years ago.
- 87% of children under five were severely malnourished when the project began. The rate is now 19%.
- Almost every child in the slums has been immunized against the 7 common childhood contagious diseases (a better rate of coverage than in California.)

Friends of DIR:

- Met twice to strategize and plan fundraising efforts.
- Took out a three-month subscription to the Foundation Center, an online resource for grant-seekers.
- From the Foundation Center database, compiled three lists of potential grant sources, prioritized by likelihood of interest in DIR.
- Assisted Frederick and Roberta Shaw in selling DIR crafts, at the UUA Pacific Western Assembly Meeting and at UUCB.
- Submitted Frederick Shaw as candidate for profiles in publications and interview subject in broadcast.
- Arranged presentations about DIR to gatherings of potential donors.

FUNdraising Team

The purpose of the FUNdraising Team is to provide financial support for the general operating budget. We generate fundraising ideas and serve as a focal point and clearinghouse for ideas from the congregation. We provide multiple avenues for generosity of time, talent, and treasure, and we build loving community as people work and play together.

In some cases we create task forces and recruit volunteers for major events; at other times we advise, assist, or collaborate with individuals and groups raising funds for the church. The Sunday Snack Table, eScrip, and the SHARES program are ongoing efforts of the FUNdraising Team.

Highlights of 2013-14:

Cinco de Mayo Fiesta, May 4–5, 2013

For this event, we combined the Saturday night dinner-dance model with the Sunday afternoon family fiesta. A silent auction of 112 auction items from 71 donors (36 UUCB and 35 outside) was the major source of revenue. Entertainment included Spanish songs performed by UUCB members Saturday night and a piñata and craft activities for children Sunday. The core planning team was Carol Carlisle, Ann Harlow, Lisa Maynard, Salene Schaffer, and Karen Tripp. Sheila Fischer designed a wonderful poster. Nan Yarbrough mounted an impressive sale of succulents and other plants. The net income for the Fiesta was approximately \$6700. A portion was donated to CCISCO.

Holiday Fair, December 8 and 15, 2013

This was a collaborative venture. The Handicrafters Group provided stuffed animals, knitted and crocheted items, jewelry, eyeglass cases, etc. Other handmade items were donated by the congregation, including Christmas decorations and an antique quilt that went into the silent auction. There was a small plant sale, and three craftspeople had individual tables with 50% of sales given to UUCB. Lunch food was provided by Minerva Mendoza-Friedman, the Freestone Committee, and the Partner Church Committee. The silent auction had 19 items, all donated by congregants. Barbara Hilbourn played a crucial planning role, and many other people helped out. Total proceeds for the event: about \$5800.

Snack Table

The snack table nets over \$5000 a year for the church and helps encourage socializing after Sunday services. Many thanks to all who have donated food, and to the stalwart regular volunteers Aria Cahir, Barbara Daniell, Dody Silver, Lynn Sullivan, Sue Sutton, Hoa Voscott, and to occasional others. Thursday Night Supper leftovers have been a welcome addition this year, and Richie Dawkins has pitched in to help get food on the table.

Costume Closet Clean-Out Sale

Donna Davis, Margaret Gudmundsson, and I, with help from the Facilities staff and others, filled the stage with excess costumes, props and furniture from the overcrowded, musty storage room and raised several hundred dollars for the church.

Land Development Task Force

For the past year and a half, the Land Development Task Force has been meeting with a number of people with experience in land development to get a better sense of what is possible. This includes a developer, a real estate attorney, a commercial realtor, numerous architects, two

geologists, civil engineers, a co-housing advocate and the Contra Costa County Planning Commission. We hired Equity Community Builders (<http://www.ecbsf.com/>), who works extensively with non-profits on land development, to help us through this process. The first hurdle, determining if we had active faults (we are on the eastern edge of the Alquist-Priolo Earthquake zone), has been passed with no appearance of active faults.

We have identified the following criteria:

- a development in concert with our values
- a risk level that does not jeopardize the financial future of the church
- a minimum amount of intrusion into the look and feel of the property
- a resulting revenue stream with significant contribution to the church (at least \$100,000/year)

As articulated at the February 2013 congregational meeting, the reason we started this investigation was the need for about a quarter million per year in additional income to cover the needed investment in a 50+ year old building. We could get that additional investment by all of us increasing our pledges by 50%, or increasing membership by 50%, or having a capital campaign every 4 to 5 years, or getting additional revenue from our buildings or land. We can also reduce expenses, but that would not be without significant cuts in personnel and programming. Some combination of the above is the most reasonable.

Preliminary estimates indicate that we could develop up to 11 lots with a net profit to the church of \$2M - \$3M. Assuming it goes into an endowment that would sustain the building in perpetuity, a 4% payout (our current policy) would provide \$80,000 - \$120,000 annually, within our target. Our next steps are to determine how we might increase the probability of being in the upper range.

The next steps involve a variety of surveys and testing that require about \$80,000. Our intent is to borrow this from the endowment, and will request approval to do so from the congregation at the May 18 meeting, along with a repayment plan. Congregational approval is required for any development decisions. Our expectation is that this is a 3-5 year project.

Stewardship Team

Our main purpose is to support the congregation in giving generously to fulfill the mission of the congregation: "to create loving community, inspire spiritual growth, and encourage lives of integrity, joy and service." This relates to the Global End stating: "Congregants experience a shared richness of love and spiritual growth, inspiring greater generosity of time, talent, and treasure."

The Stewardship team is primarily focused on the Annual budget drive, starting in the fall for the coming fiscal year. Thus, we are working with two budget years at once.

This year the team worked to fulfill the current budget goal of \$510,000 for the fiscal year 2013-2014 (ending June 30, 2014) with an Annual Budget Drive called "Stepping Up, Stepping Forward." We have 285 pledging households, totaling \$469,684. The Treasurer, and we ourselves, project we will fall well short of the ambitious goal.

In October, 2013 we started working on the Pledge Drive for FY2014-2015. The theme is "Gearing Up for the Greater Good." It continues the use of our 'gears' logo with the addition of many hearts. This year we are able to take EFT pledges and recurring contributions on line. Many of our contacts have been made through email.

I wish to acknowledge the wonderful contributions each member of our team. Salene Schaffer created our graphic designs for the logo, poster, and thank you notes. Bob Moore contributed a beautiful certificate for major donors, to which Salene added a lovely chalice to the copy. Ann Harlow has written the persuasive and effective letters for our mailings. Lisa Maynard continues her excellent work with note taking, event planning and execution, and mail merge efforts. Beth Pollard has emceed events, made many contacts with donors (as have all the team members) and Bill has anchored us all in the spiritual dimensions of giving, while offering practical advice and knowledge. This is a true team, for which I, and the congregation, can be very grateful.

Our kickoff event was a Celebration Sunday on March 2, 2014. Preceding the event, we held a celebration for major donors and those who made significant increases to their operating pledge. We encouraged lead gifts at this event. We are working with a proposed budget goal of \$460,000 this year. We have lost some high pledgers due to death, moves out of the area, and the retirement of our Ministers, who were among our highest pledgers for many years.

On March 15, 2014 most members of the Team attended a Pacific Central District Sparks for Growth Workshop on Stewardship led by Rev. Vail Weller from the UUA. Rev. Bill Hamilton-Holway gave the opening homily. It was an energizing event and we were introduced to new ideas and practices, which we hope to utilize as we go forward into the transition years before we call new permanent Ministerial leadership.

The Team is seeking your ideas, talent, and assistance as we go forward with this vital mission.

Chalice Circles

We continue to hear from Chalice Circle participants that their Circle experience helps them to feel personally connected to others, and to expand their spiritual horizons. Participants often mention the importance of the small group setting in their search for the connections of community at UUCB. The practices of sharing personal stories and deep listening to others' stories, within the covenanted container of the Chalice Circle format, strengthen these connections and help participants to feel valued and supported. The Chalice Circle topics inspire conscious exploration and formulation of our own thoughts, beliefs and values. Circle participants also extend their interaction into a different setting as they have fun working together on service projects that benefit others.

The 2012-13 Chalice Circle season ended with a celebration for Circle participants on June 7, 2013. During that season, six Chalice Circles met from October 2012 through May 2013, with some variation due to individual circumstances. Some Circles extended their meetings past May, and one new Circle also met for a brief summer 2013 season. Chalice Circles were on hiatus during the fall of 2013, as the co-coordinators put their time and efforts into the Taking Care of Our House Capital Campaign. In early 2014, four new Chalice Circles began an abbreviated Chalice Circle season, which in some cases will extend into the summer.

The main issue confronting the Chalice Circle program is the difficulty of finding facilitators. During this season and the previous one, we have been unable to find space in a Chalice Circle for everyone who was interested in participating, simply because we had so few facilitators. Ministerial support of the Chalice Circle program will change when Bill Hamilton-Holway retires in June, but we hope to continue the program, and to encourage new facilitators, in order to offer a good variety Chalice Circles during the 2014-15 season (beginning in fall 2014).

Channing Club

Chaplains

A group of ordained ministers volunteer to be chaplains after each 11am service (10 am in the summer). This group may include seminarians only if they have completed CPE (Clinical Pastoral Education) training. Rev. Jane Ramsey schedules the chaplains and provides support.

The purpose of the work of these chaplains is to provide a "listening presence" for those who feel troubled and feel the need to talk in a safe environment. At the end of each service the chaplain for that week will come to the front of the sanctuary next to the "Memory Book" and votive candles. Here a person may light a candle, write about their concern in the Memory Book and/or speak with a chaplain. The chaplain is able to refer to mental health professionals, community service organizations, and/or, with permission, to the parish minister/s.

Currently the following ministers have volunteered to be on the list of chaplains: Rev. Jane Ramsey, Rev. Sonya Sukalski, Rev. Carolyn Knowles, Rev. Theresa Hardy, Rev. Craig Scott, and Rev. Fran Moulton. All but one are ordained UU ministers; the one exception is an ordained interfaith minister and all have undergone ministerial pastoral counseling training. Coordinating Team Report

The Coordinating Team (CT) has undergone some major changes in membership during this church year. Current members are Beth Pollard, Anne Greenwood, Mary Ellen Morgan, Jane Middleton, Ellen Fisher and Rev. Bill Hamilton-Holway. Our monthly meeting times have changed to first and third Tuesday mornings from 9:30 to 11:30 am.

In July, 2013 Anne's term as Treasurer ended, but she remained on the CT. Business Administrator Mary Ellen Morgan now attends all meetings, providing the financial reporting and other administrative tasks dealing with contracts with our schools, personnel matters, financial accounting, and other business matters. Current Treasurer, Linda Laskowski only attends meetings as needed (primarily concerning budget preparation) or reporting on other issues, such as the Land Use Task Force progress.

We lost Margaret Gudmundsson in September, 2013, as her health issues overcame her. She is still sorely missed for her wise words, work with church committees and task forces and report writing.

Jane Middleton began to attend meetings, transitioning from her role as Vice President of the Board of Trustees. She resigned with one year left on her term, and was officially appointed to the CT as of February, 2014. Cynthia Asprodites also ended her lengthy service with us in February 2014 when her wife, Mary Ann Simpson, was elected to the Board of Trustees.

Mission Statement: Generation UU is a group for friends, visitors and members of UUCB, who are of age between the Young Adult Group, and the Baby Boomer Generation. Currently, our roster is made up of mainly adults in their 30's & 40's, along with their family members. We strive to build community through shared social activities, and encourage our members to recommend and/or lead activities that they think would be good to do together, in community.

The group has grown from it's inception a year ago to include over 100 members. These members include friends, visitors and members of UUCB, and is inclusive of the larger UU community here in the Bay Area! The Generation UU Group is primarily a means for getting UU's of a certain age group connected to one another. There is currently no specific team that serves the group, rather, events are led by individuals from within the group, and include many different members of the group.

Humanist Connections 2013-2014

Humanist Connections explores human flourishing and the transcendent in the absence of the supernatural. Our Sunday discussion topics include issues relating to morality and ethics, human development, evolution, the nature of the universe, love, the capacities of the brain, neuroscience, free will, the latest scientific research and discoveries, and other topics of interest. We include humanists, agnostics, devout atheists, freethinkers, religious naturalists, interested theists, everyone. All are welcome. We are wheelchair accessible.

Our mission is to provide an opportunity for intellectual, moral, and emotional engagement, development, and exchange regarding topics key to Humanism and Unitarian Universalism. We seek to provide a spiritual home and place for exploration and growth for those engaged in a "deep and responsible search for truth and meaning." "The key to Unitarian Universalism is its respectful and reverential pluralism." (Rev. John Buehrens) Part of our mission is personal growth through engagement with diverse perspectives, and with cutting edge topics. We seek to foster continued intellectual challenge and growth, echoing Unitarian Universalism's 'minds on fire.'

According to the International Humanist and Ethical Union, "Humanism is a democratic and ethical life stance that affirms that human beings have the right and responsibility to give meaning and shape to their own lives. Humanism stands for the building of a more humane society through an ethics based on human and other natural values in a spirit of reason and free inquiry through human capabilities." Our group provides a forum for exploring these issues, and operates on democratic principles.

As Humanist Connections has grown in size, scope, and popularity, we have begun establishing a Humanist community, including a weekly potluck/wine salon, expeditions to plays and movies, and a Humanist Chalice Circle. We also have an email list that now has 135+ active members. Current attendance ranges between 25-36 people each week, although we have attracted up to 45.

This year we have explored many topics which we elect together at the beginning of each month. While the format of a moderated discussion is the core of our group, allowing all who wish to be able to participate, we have also instituted a Humanist Forum on Saturday afternoons for presentations which are much more similar to traditional lecture format, helpful when a topic involves extensive unfamiliar material. In June and July we also are planning play readings, "Bayard Rustin's Journey" and "Thoreau's Night in Jail."

This year has also been a year of significant loss for us. Realtor Peter Franklin passed away last summer, followed by microbiologist Monica Riley. In response to both these events we planned a memorial service and participated in them. We were further aggrieved by the loss of our philosopher poet, H.D. Moe, and later in the spring by the death of our very popular member, Akira Chiwaki. These events emphasized how connected with each other we have become, and the importance of our humanist community in our lives.

Everyone is welcome to come visit our discussions Sunday at 12:30 in the Safir Rm. We are exploring instituting child-care as an option from 12:30 to 2 pm.

Immigration Justice Working Group (IJWG)

Mission Statement:

- To educate ourselves, each other, and our congregation on current immigration issues in our community and beyond; including economic, political, and moral issues related to immigration.
- To raise congregational and public awareness, and bring congregational witness to bear on current immigration policies that tear families apart, cause the deaths of thousands, and undermine the safety of the communities the policies were designed to protect.
- To encourage the congregation to engage in efforts aimed at changing these policies and practices.
- To partner with local community groups and organizations that are also working toward immigration justice, and take action at the local, state and national level to bring about systemic change.

Our core members are: Rev. Craig Scott, Jean Gleason, Larry Nagel, Beth Jerde, Jane Middleton, and Helen Toy. Additionally, we have 60+ members of a Google group (uucb-immigration@googlegroups.com). This list is managed by Nathan DaSilva.

During 2013, the Immigration Justice Working Group continued to meet monthly, to discuss and plan ways to support and promote immigration justice in our community and beyond. Rev. Craig Scott deserves special mention as providing inspiring readings at our meetings. Members were involved in a number of significant activities, and throughout most of the year, a table was set up in the Social Hall with literature on immigration justice, and explaining the efforts of our group. A monthly column was written for the Beacon. A web page was created for the IJWG, thanks to Lisa Harrington. Notices of interest, and notices needing community response are regularly sent out on the Google group list.

Highlights from 2013 included the following:

In late January/early February, four members of the IJWG participated in a UU College of Social Justice Borderlinks trip to the U.S.-Mexico border region, learning firsthand about experiences of immigrants there.

Throughout 2013, members of the IJWG supported and attended the monthly Prayer Vigil for Those in Detention at the West County Detention Facility. UUCB led the March vigil on the theme of "Bearing Witness to the Suffering of Our Sisters and Brothers".

Immigration worship services were held on Sunday, April 13th under the guidance and direction of Family Minister Amy Moses-Lagos. The service incorporated dance, poetry, and music.

On May 20th, several members attended California Immigrant Day in Sacramento. Members of the IJWG met with staff of elected officials to promote legislation in support of undocumented immigrants, most notably the TRUST Act.

Members also met with staff members of U.S. Senator Barbara Lee to applaud her support of comprehensive immigration reform, and to urge her to do all she can to further this campaign.

Two IJWG members participated in a "Farm Worker's Reality Tour" in July, a program sponsored by the non-profit, Human Agenda.

The IJWG collaborated with CCISCO on their Campaign 4 Citizenship. Several members attended Rep. George Miller's town hall meetings on immigration reform. One member also

journeyed to Bakersfield with CCISCO to highlight the need for immigration reform at a statewide rally there. Members participated in phone banking on several different occasions.

Continued support of DREAMers through volunteering at DACA (Deferred Action for Childhood Arrivals) workshops, and through a contribution to CLOUD, a DREAMer organization from proceeds from the UUCB Cinco de Mayo celebration.

Throughout 2013, the IJWG continued to educate the congregation on the TRUST Act, and made phone calls and wrote letters urging Gov. Brown to sign the legislation. It was signed into law in September.

Additional activities included:

A movie night at UUCB with the showing of the documentary, "Why We Come"

Participation in the CIVIC volunteer visitation program at the West County Detention Facility

A Social Justice Summer Forum facilitated by Rev. Craig Scott

Partnering with other interfaith groups on the issue of phone justice at the West County Detention Facility; and petitioning the Contra Costa County Sheriff to institute more just phone rates there

A summer RE class on immigration taught by Rev. Craig Scott and Natalie DaSilva

Participation by 11 UUCB congregants in the Fast for Families, supporting the fast in Washington, DC by undocumented immigrants, their families, and supporters, to demand an end to mass incarcerations and deportations of undocumented immigrants

In 2014, our activities are continuing. We are changing our meeting schedule to quarterly, and our activities will be centered on engaging in and responding to events and needs in the community.

In that spirit, in March the IJWG spearheaded an effort to collect donations from congregants for recycling workers who were fired as the result of an I-9 immigration audit and enforcement. Approximately \$900 was distributed to families in financial crisis. One of the fired workers spoke very movingly at the Sunday worship service on April 13th, telling her story and expressing her gratitude. She was joined by another fired couple and a union representative. Congregants welcomed them warmly after the service.

The IJWG led the March vigil at the West County Detention Facility on the theme of "Bearing Witness to Suffering, Bringing Hope". Very moving testimonials were offered by community members affiliated with CCISCO (Contra Costa Interfaith Supporting Community Organizing), to which UUCB now formerly belongs.

On April 4th, IJWG facilitator Natalie DaSilva took part in an act of civil disobedience, as part of a nationwide weekend of action to mark the tragic milestone to be reached in April of 2 million deportations under the Obama Administration. Twenty-three undocumented youth, and faith and labor leaders staged a sit-in in front of the immigration courts in San Francisco, blocking traffic. All were arrested, cited, and released.

Throughout 2013 and 2014, the IJWG has partnered with other groups who are bringing to light particularly troubling deportation cases, and have supported efforts – through petitions and phone calls to elected officials and Immigration and Customs Enforcement (ICE) – to demand the release of individuals in detention. In 2013 public pressure was successful in winning the release of a nursing mother from detention. More recently, petitions have been signed and phone calls have been made demanding that the deportation cases of two men be re-opened so the men can be reunited with their families.

The Immigration Justice Working Group is one of the ways that congregants can fulfill the UU values of social and environmental justice, and community organizations experience UUCB as an active and dynamic partner in this work.

Mist Tree Moon Circle

Mission Statement:

The Mist Tree Moon Circle adheres to the seven principles of Unitarian Universalism and to the vision statements of both affiliated congregations, the Unitarian Universalist Church of Berkeley and the Berkeley Fellowship of Unitarian Universalists. Personal Theology

The mission of the Personal Theology program is to offer opportunities for people to be introduced to new spiritual ideas, to gain wisdom from a variety of world religions and to discuss their beliefs about spiritual, ethical and theological issues. Through presentations by spiritual and theological leaders as well as church members, the program's goal is to inspire spiritual exploration, a search for truth and meaning and to encourage self-discovery. It aims to reflect UU values and offers attendees a venue for radical inquiry and free dialogue.

The weekly Sunday morning speaker series was founded in 1980 by process theologian Bernie Loomer. It has been operating continuously since then, with Martha Helming coordinating since 1990. Martha Helming turned over the Chairmanship to Barbara Rockhold in 2013. The program is funded by donations from attendees and is operated through donated time from the Personal Theology Committee, which consists of four members. It meets in the Fireside Room at UUCB approximately 37 Sundays a year at 10:00am for approximately 50 minutes.

Since April 2013, the Personal Theology Committee has concluded the Spring 2013 semester and planned and executed the Fall 2013-14 semester and the Spring 2014 semester. The

committee is currently about halfway through the planning phase for Fall 2014-15.

The committee has brought into the church many highly accomplished and informative speakers on numerous topics of theological and spiritual interest. While some of the speakers request a small honorarium, the program has been able to raise the money to accommodate those fees, plus an amount of money, which, once the speaker fees are paid, goes to the church.

The audience gets to experience a sense of connection during the question and comment period at the end of each speaker's session. This creates an opportunity for exploration and spiritual growth for those in attendance. And, due to the fact that some of our speakers are church members or are connected with UUCB in some way, it becomes a way for those members to share their time, talents and knowledge with the audience.

The program has a large number of regular attendees and has been an attraction to newcomers, many of whom have expressed that the program is an important part of their experience at UUCB. Several of our presenters have also spoken highly of the value of such a program. Since there is no other adult education program at UUCB on Sunday mornings, Personal Theology fills a much-needed function.

The overall goal and mission of the Personal Theology program is directly reflected in one of UUCB's new end statements: members can "experience and explore the wisdom that all religions have to offer and can express UU principles and values".

The Write for Your Life group was started by Beth Glick-Rieman for the spiritual growth of human beings and the well being of the earth, including peace with justice through small groups. It meets on Monday mornings from 9-11 AM.

A second group meets on Monday afternoons from 2:00-3:45pm. In December 2013, Kit Hewitt took over leadership of this group.

Our writing is a form of meditation, inspired by a poem which is read at the beginning. A major block of time is dedicated to actual writing, after which we read what we have written (or pass if we wish) and receive the gifts of listening ears and responses without judgment or criticism. The aim is personal spiritual deepening and building of a supportive community where it is safe to be fully who we are.

Participants are free to come as they choose. Some are members of the church; others come from the community. All are welcome.
